At this time, a driveway exists from the public way (Municipal Parking Lot #11) which runs around the building at Number 1006 Cambridge Street.

It is my opinion that one driveway for this small piece of property is adequate. If another driveway was constructed on Cambridge Street, it could become a drive-through and might be used as a short-cut from the parking lot. Now all vehicles must exit onto Windsor Street and go to Hampshire Street then to Columbia Street to get back to Cambridge Street.

I, therefore recommend that this driveway not be approved.
