Attached is an order requesting the appropriation of \$37,494.00 to the grant fund from the City of Boston Economic Development and Industrial Corporation (EDIC) to the Human Services Salary & Wages Account \$27,694.00 and Other Ordinary Maintenance Account \$9,800.00 to provide funds for educational and job preparation services for up to 18 enrollees.
