From: A-1 Permanent Salaries

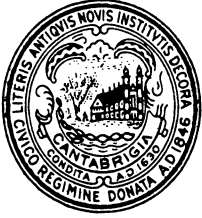
To: D-16 Services not o/w coded \$1000.00
