

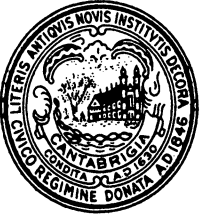

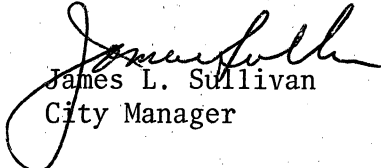

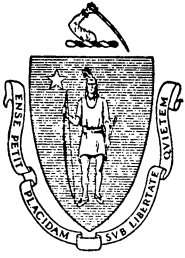

IN THE YEAR ONE THOUSAND NINE HUNDRED AND SEVENTY-EIGHT

AN ACT AUTHORIZING THE LICENSE COMMISSION OF THE CITY OF CAMBRIDGE TO ESTABLISH CERTAIN LICENSE FEES

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. "Section 1 of Chapter 212 of the Acts of 1969 is hereby amended by inserting at the end of said Section the words hackney carriages, and automatic amusement devices as defined by General Laws, Chapter 140, Section 177A."

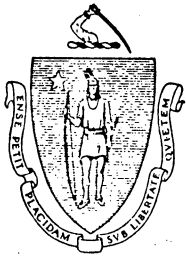
Section 2. Said Act shall now read as follows:

Notwithstanding any provision of law to the contrary, the fees to be charged by the City of Cambridge for the issuance of the following licenses shall be such as may be established from time to time by the License Commission of said City: auctioneers, common victualers, lodging houses, hackney carriages, and automatic amusement devices as defined by General Laws, Chapter 140, Section 177A.
