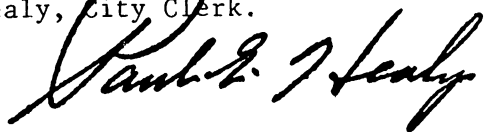

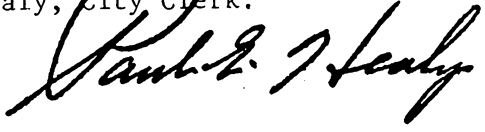

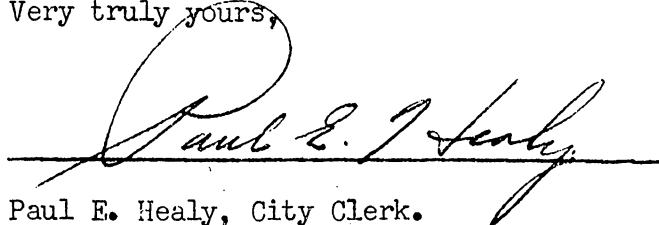
Dear Neighborhood Representative:

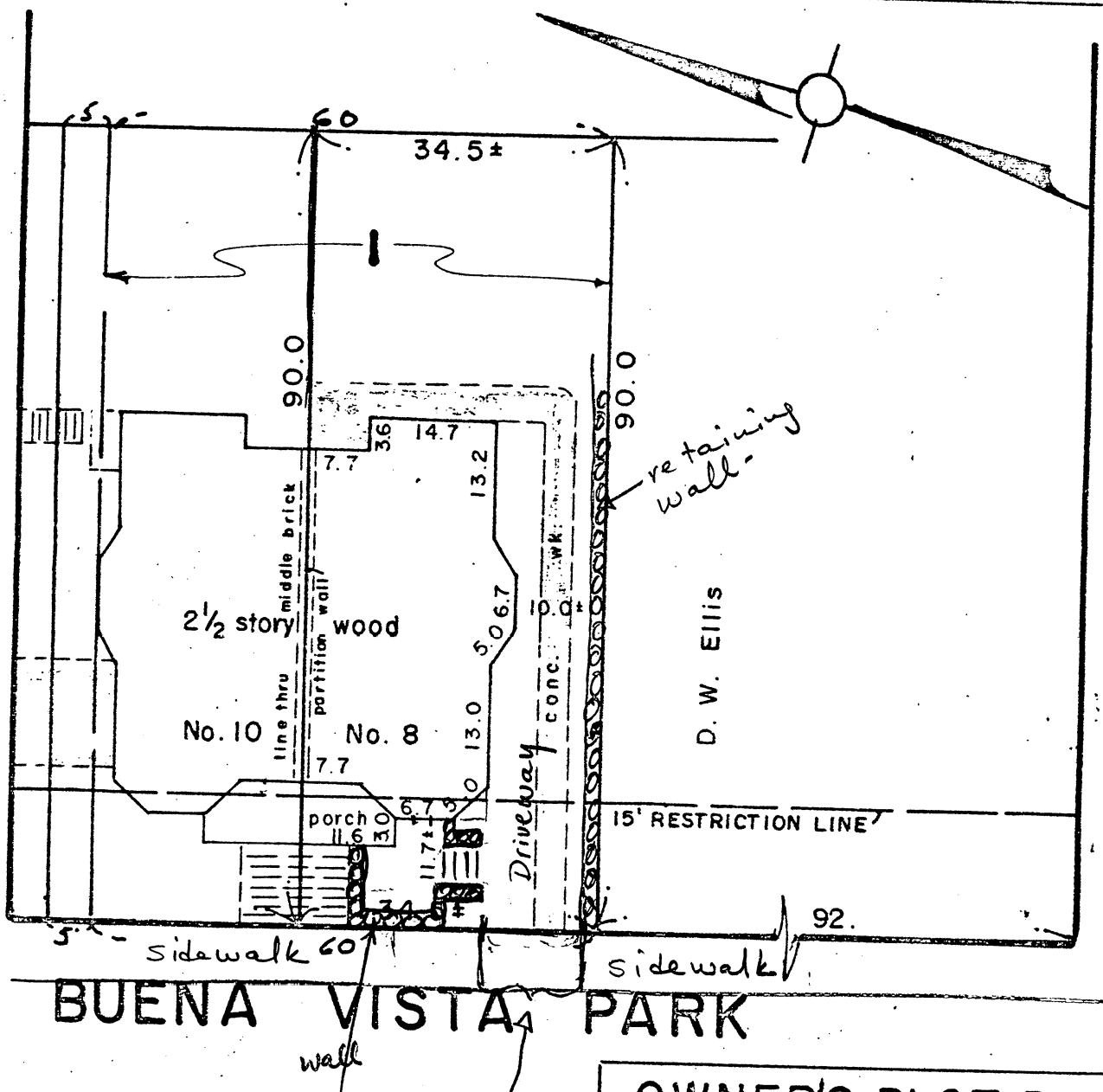

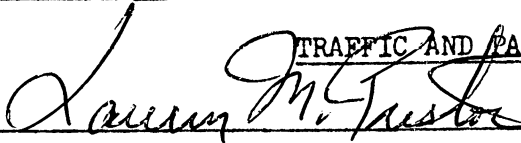
