That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to Skolion Coffee Shop for the erection of an awning at the premises numbered 480 Massachusetts Avenue, Cambridge.

Provided that, before erecting the above named awning, the petitioner shall obtain a permit from the Building Department and file with the City Clerk a satisfactory bond in the sum of Three Thousand Dollars (\$3,000) conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said awning.

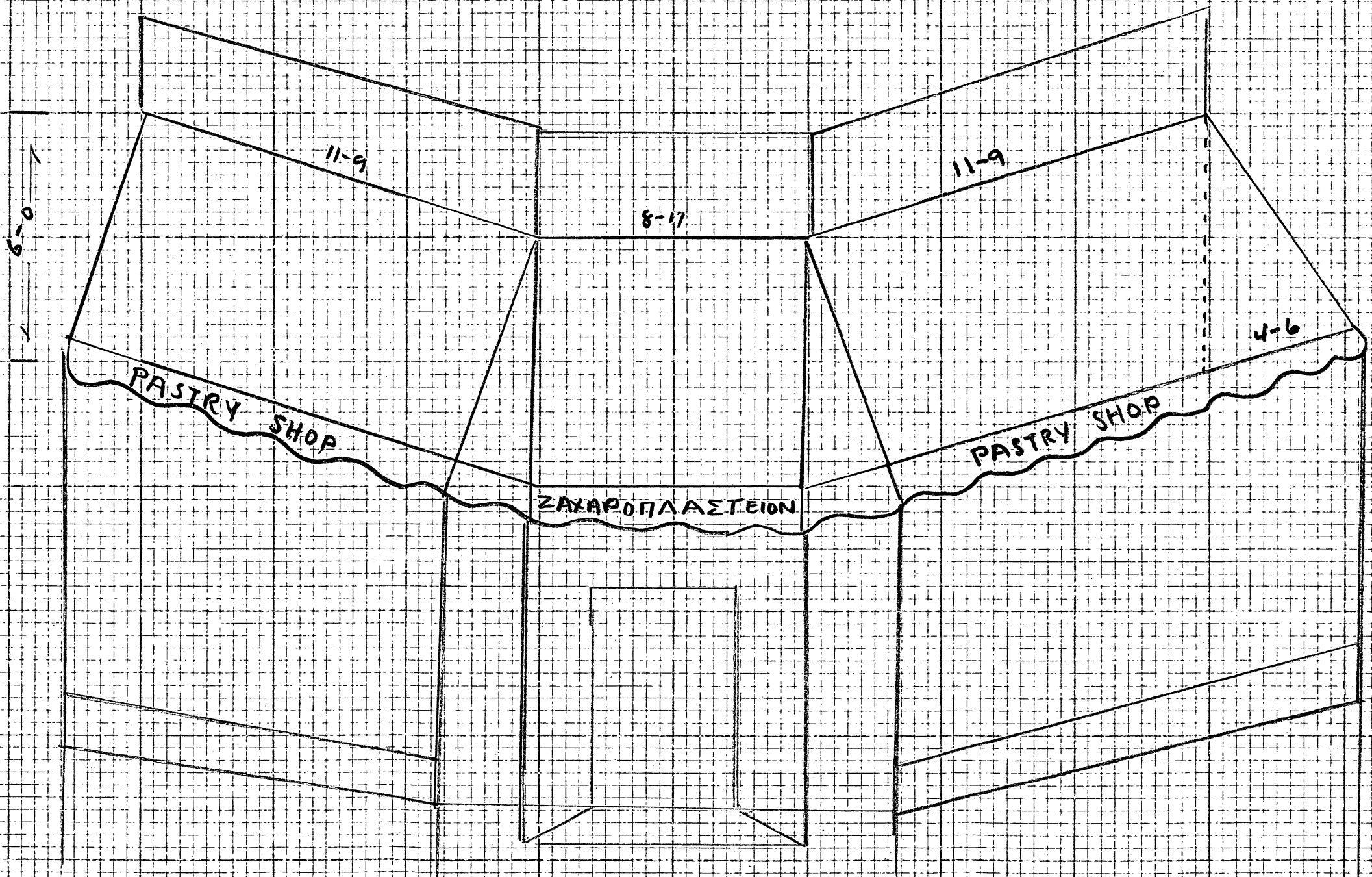
