Petition of Cambridge Electric Light Company for authorization and approval of the issue of notes not exceeding in the aggregate \$2,750,000 to mature more than one year after date thereof, but not later than December 31, 1957, and to apply proceeds to the extent of \$500,000 to pay outstanding bank notes and to use balance of the proceeds in partial reimbursement of Plant Replacement Funds Assets account and to borrow as required from time to time from its Plant Replacement Fund Assets account additional amounts not exceeding together with previous borrowings outstanding after partial repayment from note proceeds as aforesaid the aggregate amount of \$5,000, to be used for the purpose of financing in part extensions, additions and improvements to its plant and properties.

Upon the foregoing petition the Department of Public Utilities will hold a public hearing at its hearing room, 166 State House, Boston, on Monday the 28th day of December, 1953 at 10:00 o'clock in the forenoon.

And the petitioner is required to give notice of said hearing by publication hereof once at least 14 days prior to said date in the Boston Post and Cambridge Chronicle-Sun,

to serve a copy hereof by registered mail at least 14 days prior to said date on the Mayor and City Clerk of Cambridge and Chairman of Board of Selectmen and Town Clerk of Belmont,

and to make return of service and publication at the time of hearing.
