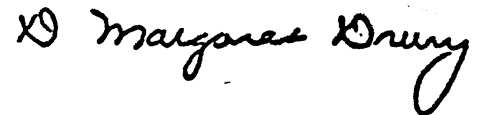

To The Honorable, The City Council:

I am hereby requesting an appropriation of \$74,305.00 in the Grant Fund of the Human Services Salary and Wages Account (\$22,000.00) and Other Ordinary Maintenance Account (\$52,305.00). Funds have been awarded to the Office of Workforce Development as a part of the HUD Economic Development and Support Services Grant through the Cambridge Housing Authority. Funds will be used to expand the capacity of the Cambridge Employment Program to continue to fund a vocational case manager to assist with case management services to Cambridge residents seeking employment, particularly those residing in public housing. Funds will also be used to cover the cost of a part time job developer to reach out to employers to generate job leads for Cambridge Employment Program clients.
