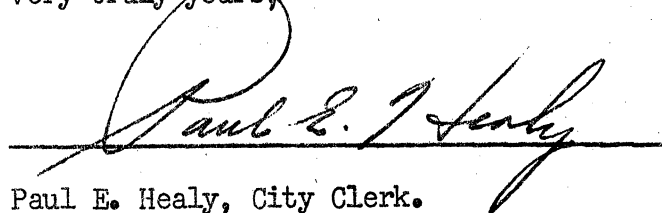

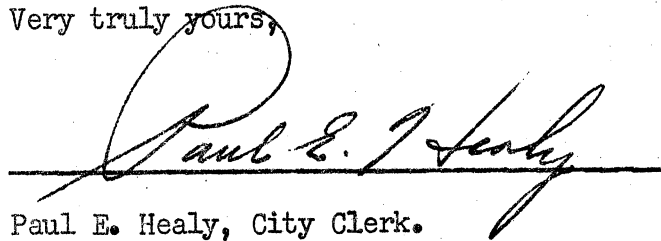

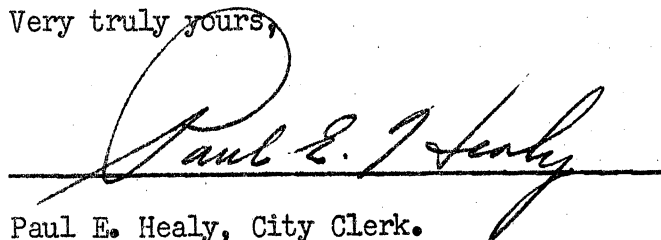

thirty days from the receipt of the bill.

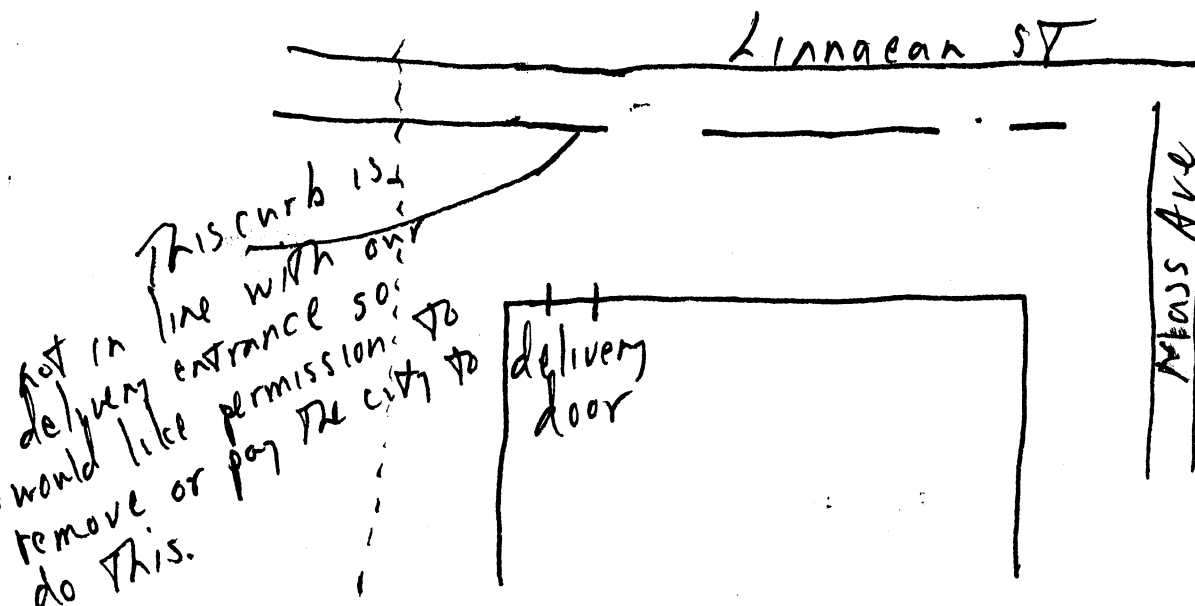
