November 19, 1973

**WHEREAS:**

Leslie L. Hutchinson, a former employee of the Public Works Department of the City of Cambridge, entered the service of the Public Works Department on February 8, 1937 and was pensioned on May 14, 1945 under the provisions of Chapter 32 Section 57 of the General Laws and died on September 30, 1973, and

**WHEREAS:**

At the time of his death said employee had no right to elect that benefits be paid to his survivor, said employee leaves as his survivor, his widow, Helen Hutchinson who has not remarried and is not receiving any retirement allowance or pension under the provisions of any general or special law, therefore be it

**ORDERED:**

That, under the provisions of Chapter 32 Section 101 of the General Laws, Tercentenary Edition and amendments theret, that in order to promote the public good, and in consideration of the long and meritorious service performed by Leslie L. Hutchinson an annuity be granted to Helen Hutchinson, widow of Leslie L. Hutchinson of \$1680.00 per year as long as she does not remarry.

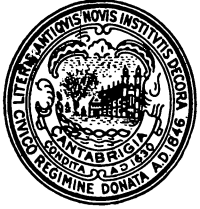

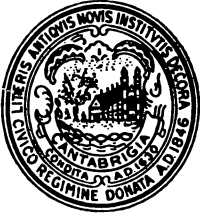
