Notice is hereby given that in accordance with the provisions of Chapter 40A, Section 5 of the General Laws, Tercentenary Edition and amendments thereto, that the Committee on Ordinances, comprised of the entire membership of the City Council, will hold a public hearing on Thursday, May 15, 1986 at 6:00 P. M. in the Sullivan Chambers, City Hall, Cambridge, Massachusetts on a petition by the City Council that would create a new subsection of the Zoning Ordinance of the City of Cambridge called Subsection 3.13 - Central Square Moratorium on Fast Order Food and Automobile Oriented Fast Order Food Establishments and to renumber existing Subsection 3.13 as 3.14. The moratorium on the establishment of new Fast Order Food Establishments and Automobile Oriented Fast Order Food Service Establishment would be in effect until March 31, 1987 and would not allow any building or occupancy permit to be issued for new construction or renovation of an existing structure within an area as shown on the accompanying map.
