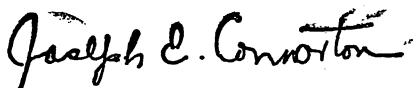

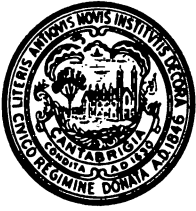

Attached please find for your review and action an order requesting the transfer of \$115,000.00 from the Hospital and Ambulatory Care Fund Other Ordinary Maintenance account to the Hospital and Ambulatory Care Grant Fund. This transfer will be allocated as follows: Salaries and Wages, \$53,230.00 and Other Ordinary Maintenance, \$61,770.00.
