Dear Mr. Black:

In response to your letter of November 24, 1976, please be advised that all communications relative to parking in the City of Cambridge should be addressed to George Teso, Director of Traffic and Parking, City Hall Annex, 57 Inman Street, Cambridge, MA 02139. Under the law adopted by the City of Cambridge, Mr. Teso will be able to answer your problem relative to parking in the City of Cambridge. I have already sent a copy of your letter to Mr. Teso.

In response to Question No. 2, the City Manager appoints the members of the Cambridge Housing Authority subject to the confirmation by the members of the City Council. The Cambridge Housing Authority has jurisdiction over all housing areas in the city and must determine who can park on Housing Authority property.

In response to Question No. 3, the City Manager is the sole authority charged with the responsibility of appointing the Director of the Cambridge Housing Authority.
