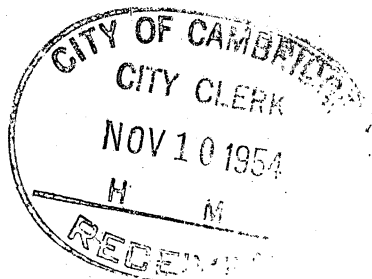

Petition of Cambridge Electric Light Company for approval and authorization by the Department of

1. Extension of the maturity date of its outstanding bank indebtedness, authorized under D.P.U. 10748 in the aggregate amount of \$2,100,000 from June 30, 1955 to December 31, 1957.

2. To issue additional evidences of indebtedness payable at periods of more than one year after the date thereof to be borrowed prior to December 31, 1956, to mature not later than December 31, 1957, in amounts not exceeding in the aggregate \$900,000 to bear interest at a rate not exceeding 3½% per annum and to apply the proceeds in partial reimbursement of the Plant Replacement Fund Assets account.

3. To borrow as required from time to time from its Plant Replacement Fund Assets Account additional amounts not exceeding together with previous borrowings outstanding after partial repayment from the note proceeds as aforesaid, the aggregate amount of \$6,000,000 to be used for the purpose of financing in part extensions, additions and improvements to its plant and properties.

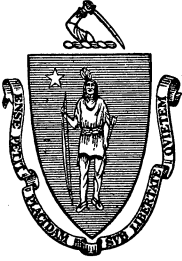
Upon the foregoing petition the Department of Public Utilities will hold a public hearing at its hearing room, 166 State House, Boston, on Tuesday the 23rd day of November, 1954 at 10:00 o'clock in the forenoon.

And the petitioner is required to give notice of said hearing by publication hereof once at least 14 days prior to said date in the Boston Herald and Cambridge Chronicle and to serve a copy hereof by registered mail at least 14 days prior to said date on the Mayor and City Clerk of Cambridge and Chairman of the Board of Selectmen and Town Clerk of Belmont, and to make return of service and publication at the time of hearing.


