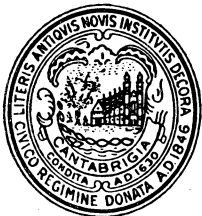

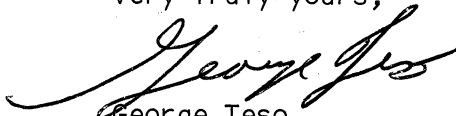
Dear Mr. Healy:

I have viewed the proposed driveway widening at 38 Regent Street and agree that the driveway should be widened to facilitate the flow of traffic in and out of the parking facility.

I recommend that this driveway widening be approved on the condition that it be widened from 10' to 15' and not from 10' to 20' as proposed. To widen this driveway to 20' would tie into an existing 30' driveway and that would not leave any delineation between the two driveways.

A five foot section of curb should be left between the two driveways to allow for future posting of signs.

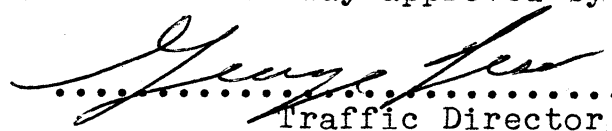
