TO THE HONORABLE THE CITY COUNCIL:

The Cambridge Committee of Elders, mindful of its responsibility to not only the elderly of this city, but also to all those who live in Cambridge of whatever age, presents herewith a PETITION TO RETAIN RENT CONTROL.

This issue is of particularly urgent concern to older people whose incomes do not rise with inflation or with the unrealistically inflated Cambridge housing market. Perhaps next to health care we find housing to be our most urgent concern. The present Rent Control ordinance allows many of us to continue to live in Cambridge. Abolition or substantial modification would force many of us to leave.

We are also mindful of the many young people who are starting their working lives in entry-level jobs. We feel that they, too deserve protection from exploitative development. One of the riches of this city which cannot be expressed in dollars and cents is the diversity of its population. We want to protect and preserve that diversity.

For the reasons enumerated above, THE CAMBRIDGE COMMITTEE OF ELDERS earnestly requests your careful consideration of the attached Petition which so many of our fellow-citizens have joined us in signing.


