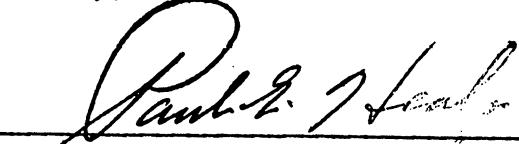

Enclosed herewith you will find the petition of Margaret M. Collins

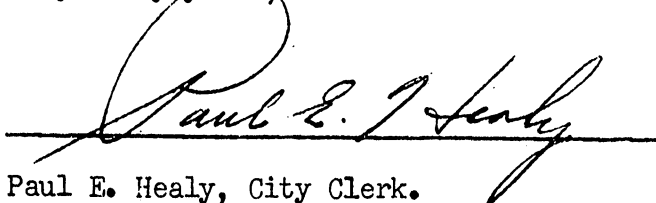
requesting a driveway at the premises numbered

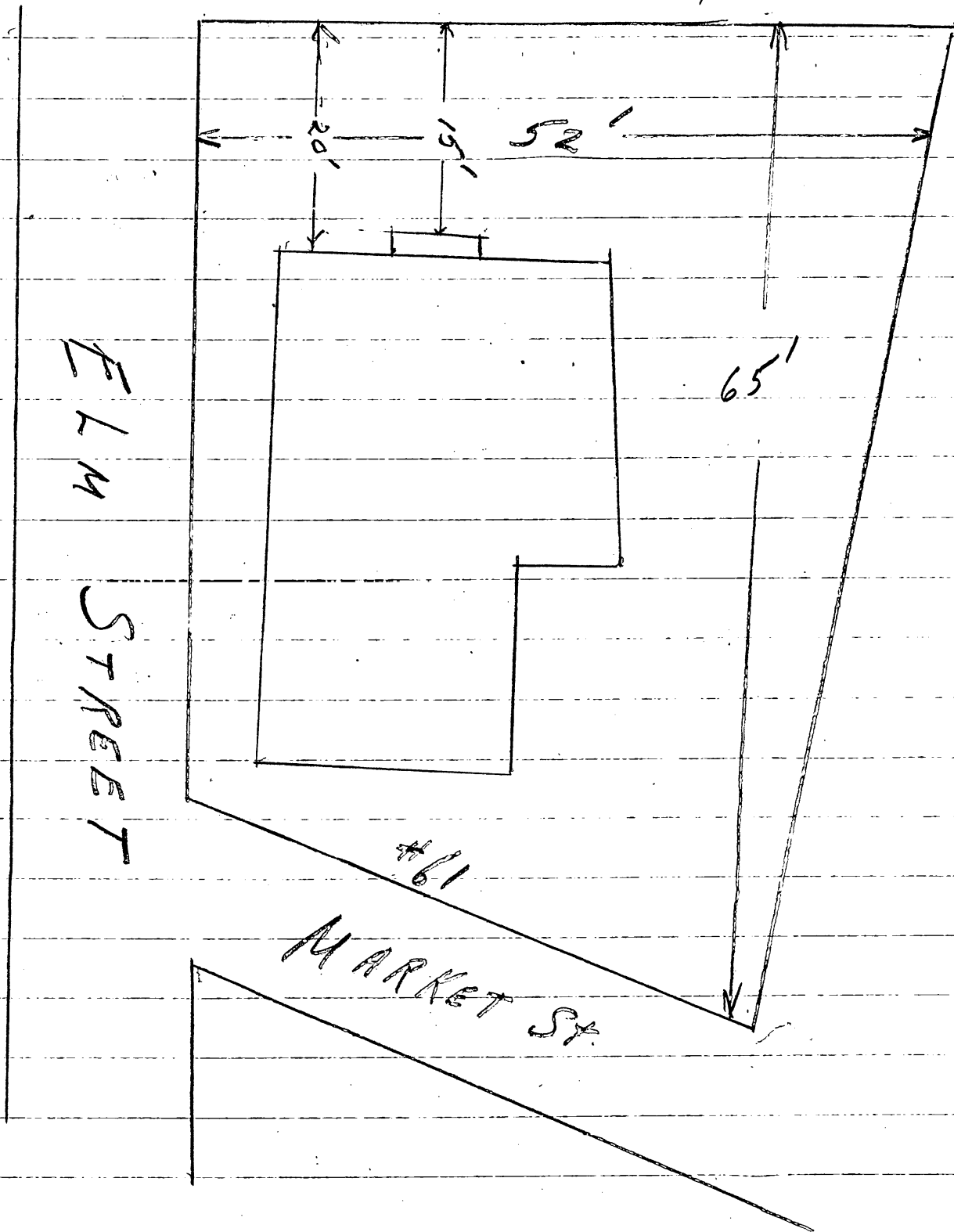

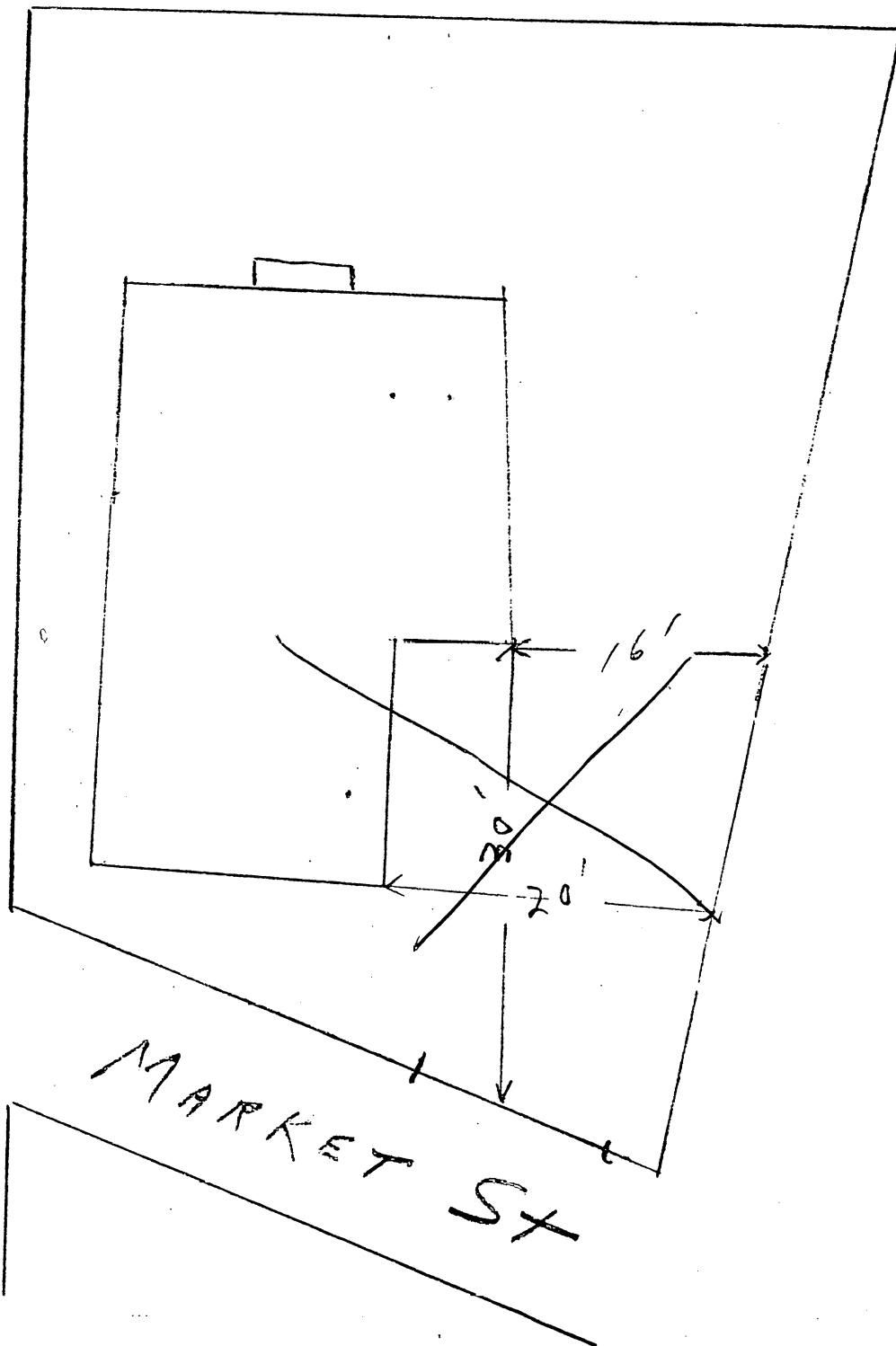

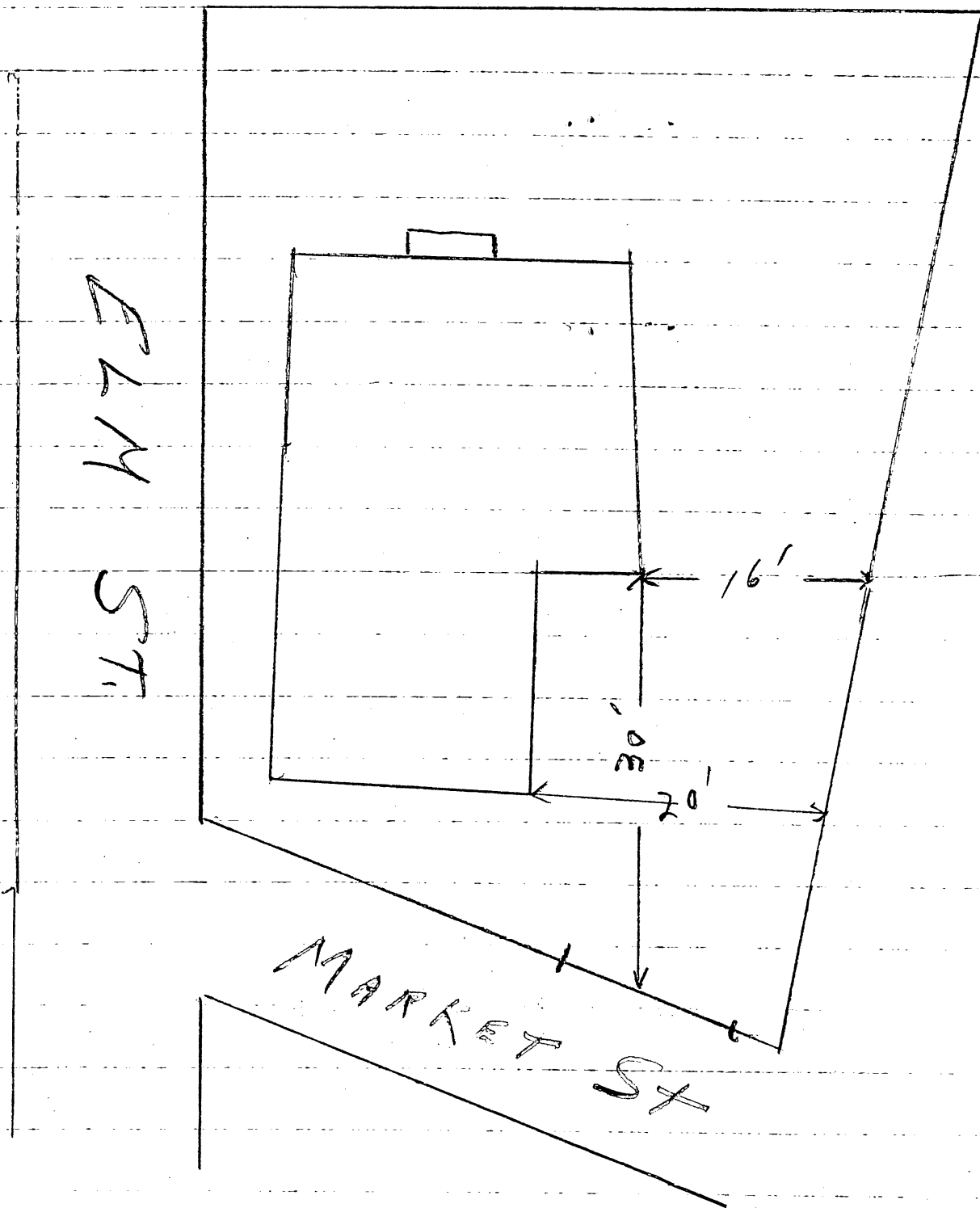
