ORDERED:

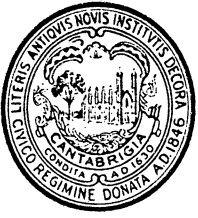

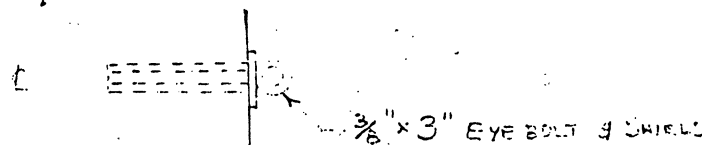
DETAIL "A"

REPLACES 4-CABLES ANTI-SWAY GUY CABLES

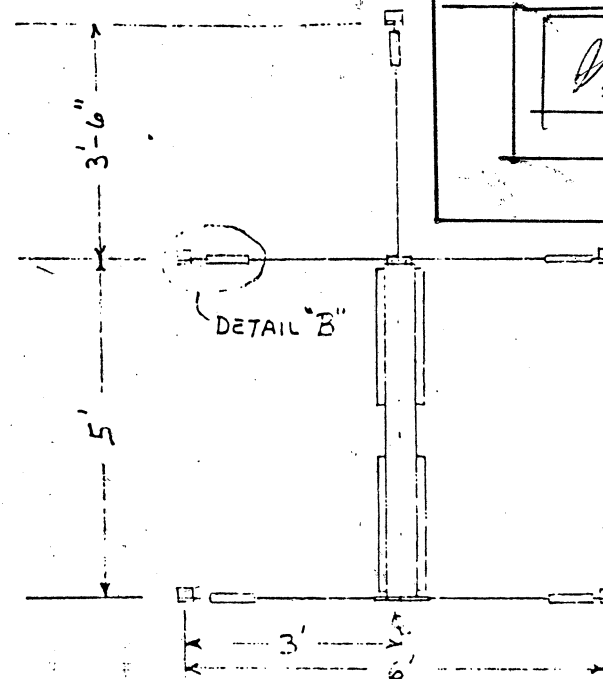

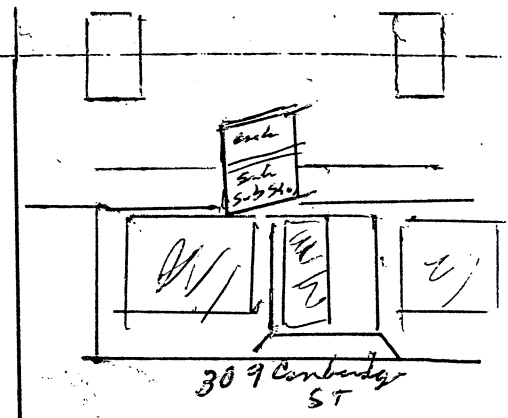
