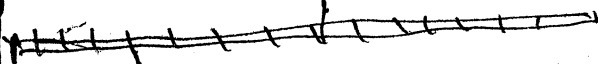
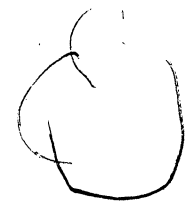

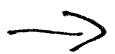

Location of proposed driveway 167 UPLAND RD. Street

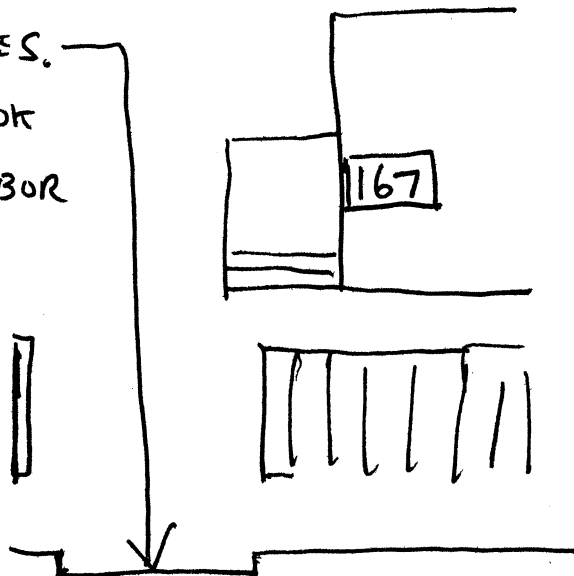
