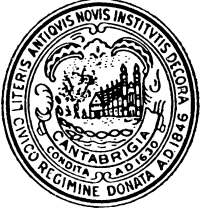




This transfer is necessary to implement the supplementary appropriation requested by the hospital for payment of positions, unfilled and new, in the 1972 budget.

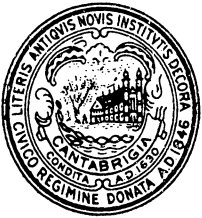


To the Honorable, the City Council:

I wish your Honorable Body to know that I have conferred with Dr. Hartgering, Mr. MacLeod and others at The Cambridge Hospital concerning the 1972 Budget.

I have previously indicated to your Honorable Body that I was agreeable to making adjustments in certain areas. I now submit for your hopefully favorable consideration an increase in the A-1 Permanent Employees account of \$84,170.00, which together with a transfer appropriation \$31,800.00 will permit additional nursing and physician positions in the 1972 budget.
