The Commonwealth of Massachusetts

IN THE YEAR ONE THOUSAND NINE HUNDRED AND SEVENTY.

AN ACT Authorizing the City of Cambridge to Appropriate Money For, and To Pay, Certain Unpaid Bills.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. That the City of Cambridge is hereby authorized to appropriate money for and the Treasurer of said City is hereby authorized to pay certain unpaid bills of the Cambridge Hospital for medical supplies and services totalling \$148,291.44 and of the City of Cambridge to the Royfax Company for leasing services totalling \$20,258.44.

To the Honorable Senate and House of Representatives of The Commonwealth of Massachusetts
in General Court assembled.

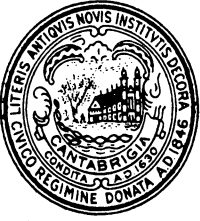
