IN CITY COUNCIL

September 15, 1980

ORDERED:

In a legally constituted meeting of the Cambridge City Council in the City of Cambridge, acting in accordance with the Massachusetts Legislative Acts of 1980, Chapter 416, Section 2, it was voted to accept all provisions as stated in legislation, as follows:

Chap. 416. Relative to the Qualification of Certain Assessors.

Be it enacted, etc., as follows:

Section 1. Chapter 797 of the Acts of 1979 is hereby amended by striking out section 22 and inserting in place thereof the following section;-

Section 22. Notwithstanding any provisions of section one of chapter fifty-eight of the General Laws, as amended by section three of this act, any person who on the effective date of this act shall have been elected or appointed an assessor, assistant assessor, supervisor of assistant assessors, district director of assistant assessors in any city or town and who is continuing to perform such duties on the date the commissioner establishes the minimum standards for qualifications of assessing personnel required by said section one. In no event shall said individuals be exempt from any continuing education requirements established by the commissioner.

Section 2. This act shall take effect upon the acceptance of the city council in a city, the town council in a city having a town council form of government and by the board of selectmen in a town.

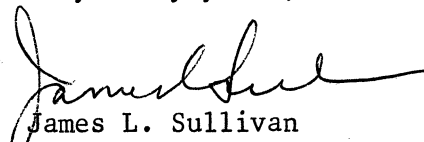
