At the last City Council meeting, held at the Morse School to discuss crime in the Cambridgeport area, several issues were raised. Those related to your department were:

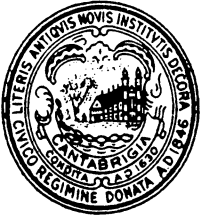
1. Trimming trees which block light and shrubs which provide hiding places.

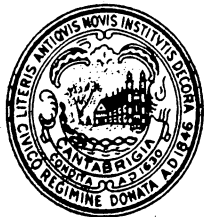
1. More streetlights in key locations
