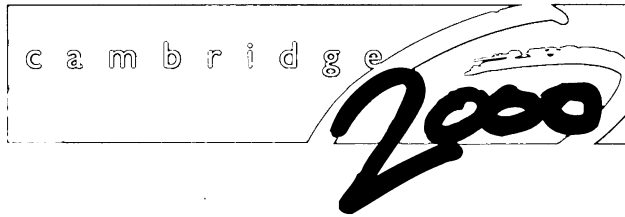

I am hereby requesting the appropriation of a grant from the Massachusetts Historical Records Advisory Board and the Secretary of State for \$6,525 to the Grant Fund Historical Commission Salaries and Wages account (\$2,025) and Other Ordinary Maintenance account (\$4,500) to provide funds to develop a documentation plan for the continuing identification, collection, preservation, and use of the City's public and private records.
