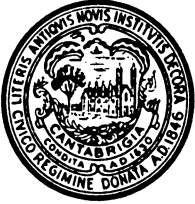

To the Honorable, the City Council:

Attached please find for your review and action an order requesting the acceptance and appropriation of a grant in the amount of \$2,485,466 from the Executive Office of Communities and Development to the Department of Human Service Programs Grant Fund, Other Ordinary Maintenance account.

These monies will fund the 1986 Low Income Home Energy Assistance Program begun on October 1, 1985. Fuel Assistance benefits will be available to all eligible households facing difficulties in paying their bills. Direct payments to oil dealers or utility companies will be made on actual monthly heating bills; rental payments may also be made for eligible tenants whose heat is included in their rent.

Passage of this order is recommended.
