- To: C-7, Office Furniture.

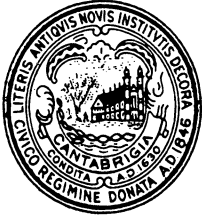
The first request is made due to a deficit in the codes and the second request is made so that a file cabinet may be ordered.

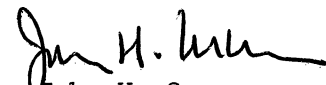
