To The Honorable, The City Council:

I am hereby requesting the appropriation of \$31,675.00 in the Grant Fund of the Department of Human Services Salaries and Wages Account (\$30,340.00) and Other Ordinary Maintenance Account (\$1,335.00) from the Massachusetts Department of Education through Employment Resources Incorporated. This grant, awarded through the Governor's 8% Job Training Partnership Act Education Coordination Adult Literacy Grant, will be used by the Community Learning Center. Eighteen students will be served in twelve slots in reading, math, English as a Second Language, computer skills, and career awareness for fifteen hours a week from September 1996 to June 1997. The grant will cover teachers' salaries and benefits and supply costs.
