Dear Mr. Healy:

I have reviewed the proposed driveway located at #10 Centre Street that is to be used for the stowing of two 6 cu. yd. dumpsters. These dumpsters are required by the Health Department due to the fact that the building was in violation of the Health Code by stacking garbage on the street for collection.

I recommend that this driveway be approved with the following conditions.

1. That the curb cut start at least 5' from the property line.
2. That at no time shall this area be used for the parking of motor vehicles.
3. That this area meet all the requirements of the Zoning Laws and Health Codes of the City.
