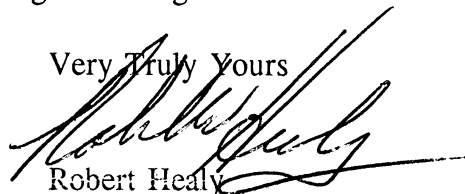

To The Honorable, The City Council:

I am hereby requesting the appropriation of \$70,000.00 into the Grant Fund of the Department of Human Services Salary & Wages Account (\$42,163.00), Other Ordinary Maintenance Account (\$25,637.00), and Travel & Training Account (\$2,200.00) from the Massachusetts Department of Public Health, Tobacco Control Program. DHSP operates the Tobacco Coalition grant funded by the Department of Public Health through the Commonwealth's tax on cigarettes. The money is to be used to develop a citywide coalition to address issues related to tobacco, to increase awareness of tobacco's harmful effects and to coordinate the activities of the various Massachusetts Tobacco Control Program grantees serving Cambridge.
