Attached please find for your review and action an order requesting the acceptance and appropriation of a grant from the Department of Mental Health for \$1,774,735.00 to the Health and Hospital Services Salaries and Wages account (\$904,953.00) and Other Ordinary Maintenance account (\$869,782.00) to provide funds for psychiatric, psychological and medical services at Metropolitan State Hospital.
