



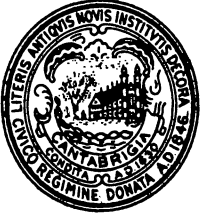

To the Honorable, the City Council:

Attached is an order requesting the appropriation of a grant from the Department of Health and Human Services for \$1,000,000 to the Public Investment Fund Extraordinary Expenditure account. This grant, which was originally accepted by the City Council on December 19, 1983, provides funds for the acquisition and development of a rental facility to be used as "incubator" space for start-up businesses and the establishment of a venture loan guarantee fund for utilization by these incubator and other small businesses which will provide training and job opportunities for low and moderate income City residents. Rental fees from this facility will be used to support and expand the services of the Boys and Girls Club by serving as a match to leverage additional funds from the Hayden Foundation.

The combination of these sources of income will be used to acquire and rehabilitate St. Mary's Gymnasium for use as a permanent recreation facility.

Passage of the enclosed order is recommended.
