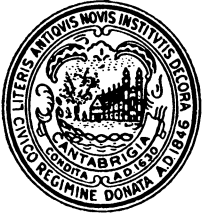

C-16 Wearing Apparel \$500.00

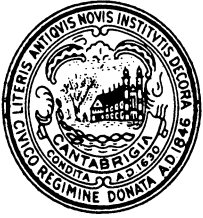
Same to be provided by appropriation from available funds in the Parking Fund.


