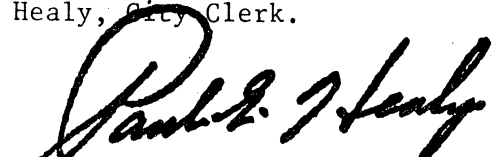

Enclosed herewith you will find the petition of James G. Buda

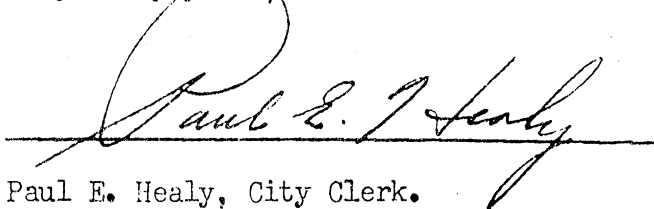
requesting a driveway at the premises numbered

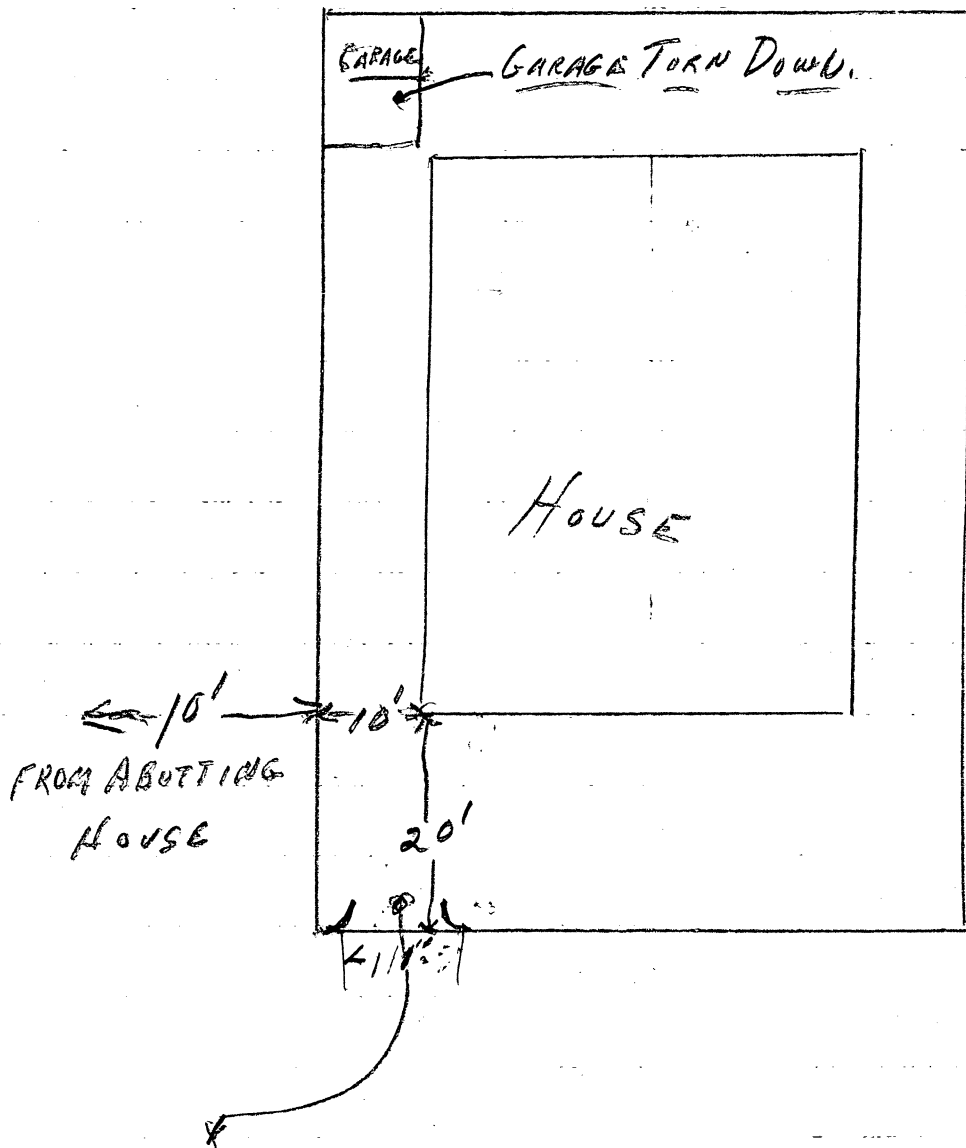

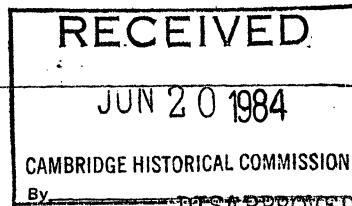
