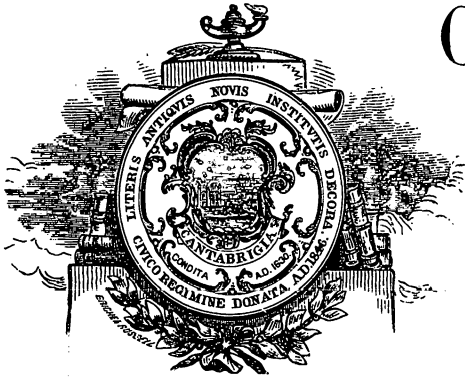




CITY OF CAMBRIDGE.

IN BOARD OF ALDERMEN,

April 22 1874.

WHEREAS: It is adjudged by this Board that the public necessity and convenience require that

Auburn Street
 between Brookline and Sydney St.
 should be laid out as a public Street. Ordered that a strip of land *Forty feet*
 in width between

Brookline and Sydney Streets

included between the *Red* lines as shown on a plan drawn by

J. G. Chase, City Engineer,
dated December 8, 1873.

and now before this Board, be taken for public use and laid out as a public Street.

Ordered that *no* damages be allowed for the land so taken ~~as aforesaid~~. *and*
that thirty days be allowed for the
removal of all fences or other obstructions
standing on the land so taken as aforesaid.
