Gold Star Court and Max Avenue are unaccepted ways. The requested repairs and/or construction for these streets has been reviewed. The nature of the requests made require these streets to be accepted as public ways.

Gold Star Court and Max Avenue cannot be brought into compliance with the City of Cambridge Planning Board Minimum Standards for Acceptance for Private Ways as Public Ways. Therefore, the repairs/construction as requested cannot be completed at this time. However, efforts will continue to be made to perform the necessary cursory maintenance to insure proper use of the streets.

A study group has been formed to review and revise the Cambridge Planning Board Minimum Standards for Acceptance for Private Ways as Public Ways. The study group includes Community Development, Public Works, Traffic, Parking and Transportation, Planning Board Representatives and other staff agencies as required. Representatives from these offices have already met to begin the work. A second meeting is scheduled for November 7, 1995.
