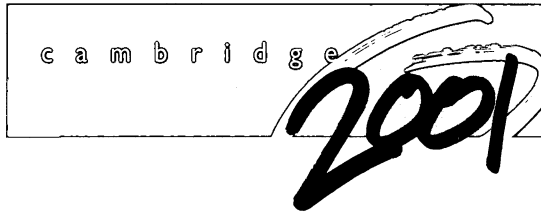

To The Honorable, The City Council:

I am hereby requesting the appropriation of a grant from the Massachusetts Department of Public Health for \$125,000 to the Grant Fund Human Services Salaries and Wages account (\$94,920), Other Ordinary Maintenance account (\$28,580), and Travel and Training account (\$1,500) to provide funds to be used by the Cambridge Prevention Coalition to reduce alcohol use by Cambridge youth ages 12-17 by implementing a science-based environmental strategy to address both community norms and underage access to alcohol. This appropriation will be used to cover a portion of the salaries of three staff members as well as program operating costs and training.
