To the Honorable, the City Council:

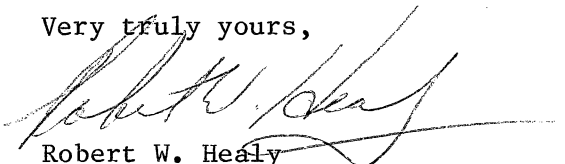
Attached please find for your review and action an order requesting a supplemental appropriation in the amount of \$10,000 to the License Commission Other Ordinary Maintenance Account. The funds are needed to hire an independent, objective consultant (or consultants) to advise the Cambridge Taxicab Advisory Committee on approximately twenty controversial taxicab-related issues now under study and at an impasse. This Committee is meeting between May 14 and May 26, 1987. There are two kinds of consultants who are needed:

- 1). a regulatory economist; and
- 2). transportation planner

The first person to perceive the need for such outside assistance was Police Chief Paolillo. The recommendations of the Cambridge Taxicab Advisory Committee are expected to be finalized on May 28th for transmittal to the City Council for its June 1st meeting.

Passage of this order is recommended.
