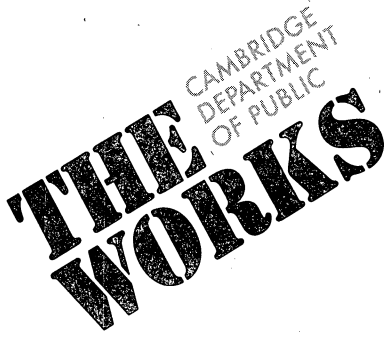

The City Council recently approved a transfer of funds from the Street Preservation Offset Fee (SPOF) account to pay for overlaying several streets including Prescott Street.

Harvard University will pay for the entire cost of the overlay of Prescott Street under the provisions of the SPOF Program.

WHEREAS: There are complaints with regard to Prescott Street and its condition due to construction over a period of years on the street; and

WHEREAS: Due to this construction there has been damage to the street condition, as well as a loss in trees which help with regard to the beautification of the street; now therefore be it

ORDERED: That the City Manager be and hereby is requested to confer with the City Arborist and the Commissioner of Public Works to see what interim and long-term steps can be taken to improve the appearance of Prescott Street; and be it further

ORDERED: That the City Manager be and hereby is requested to contact Harvard University with regard to a role that the University can play in improving this situation, as the Harvard has played an active role in construction activity on the street; and be it further

ORDERED: That the City Manager be and hereby is requested to report back to the City Council by June 8, 1992.

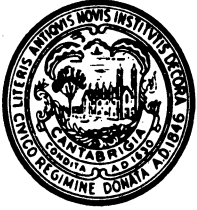
