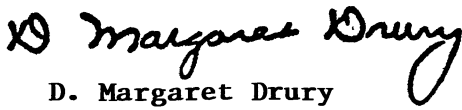

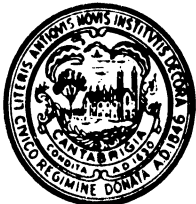

To The Honorable, The City Council:

I am hereby requesting an appropriation of \$367,193.00 in the Department of Human Service Programs' Planning and Development Division Grant Fund Salary and Wages Account (\$17,485.00) and Other Ordinary Maintenance Account (\$349,708.00). The U.S. Department of Housing and Urban Development has awarded these funds to DHSP under the Stewart B. McKinney Homeless Assistance Act. The purpose of the grant is to provide supportive housing related services to people at risk of homelessness. Funds will be used for grant management support and to subcontract with local agencies for transitional housing.
