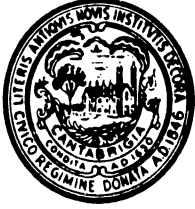

To The Honorable, The City Council:

I am hereby requesting an appropriation of \$49,775.00 in the Grant Fund of the Department of Human Services Programs' Workforce Development Divisions' Other Ordinary Maintenance Account from HUD's Economic Development and Supportive Services Grant through the Cambridge Housing Authority. These funds will be used to expand the capacity of the Cambridge Employment Program by hiring a vocational case manager to provide case management services to Cambridge residents seeking employment, particularly those residing in public housing. The vocational case manager will coordinate support services that will allow individuals to conduct a successful job search.
