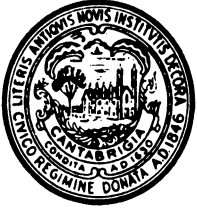
Please have the officers under your command who are assigned to the North Cambridge Area, make frequent checks of the Matignon road area due to complaints of m/v tires being slashed.
