To: B-2, Postage.


From: F-1, Subpoena Fees, the sum of \$30.00

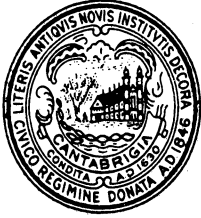
