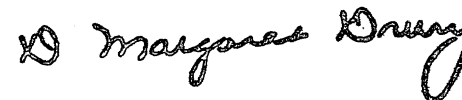

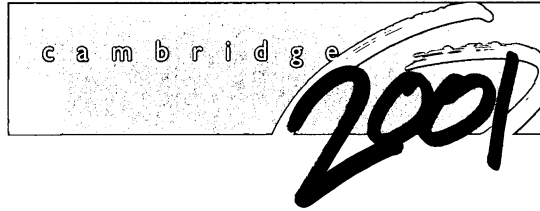

To the Honorable, the City Council:

I am hereby requesting an appropriation of \$106,000 in the Community Development Department Public Investment Fund Extraordinary Expenditures Account (\$100,000), and the Grant Fund Other Ordinary Maintenance Account (\$6,000). The Massachusetts Department of Housing and Community Development has awarded funds to establish a Purchaser Assist Program. The Public Investment funds will be used to provide down payment and closing costs assistance to approximately 10 low- and moderate-income first-time homebuyers. The Grant funds will be used for administrative costs to support the program.
