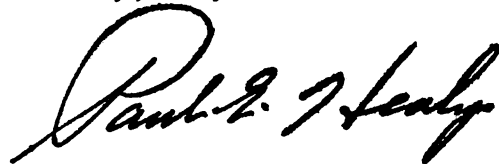

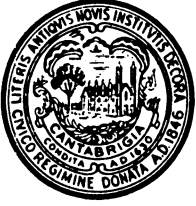

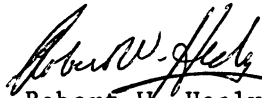

To the Honorable, the City Council:

Attached is an order requesting the appropriation of a grant from the Central Square Association for \$12,000.00 to the Community Development Extraordinary Expenditure account to be used as a portion of the local match for the City and Town Commons Program Grant. The local matching funds, which also include \$157,000 in Community Development Block Grant funds, \$120,000 in General Fund Revenues (previously appropriated to the Public Investment Fund), \$5,000 in in-kind services, and \$280,000 in MBTA Central Square Station Improvements, will supplement the grant in providing for land acquisition and development.

Passage of this order is recommended.
