Mr. OWEN:

I wish to put in the Record the secret treaty of Verona of November 22, 1822, showing what this ancient conflict is between the rule of the few and the rule of the many. I wish to call the attention of the Senate to this treaty because it is the threat of this treaty which was the basis of the Monroe doctrine. It throws a powerful white light upon the conflict between monarchical government and government by the people. The Holy Alliance under the influence of Metternich, the Premier of Austria, in 1822, issued this remarkable secret document:

AMERICAN DIPLOMATIC CODE, 1778-1884

The undersigned, specially authorized to make some additions to the treaty of the Holy Alliance, after having exchanged their respective credentials, have agreed as follows:

ARTICLE 1. The high contracting powers, being convinced that the system of representative government is equally as incompatible with the monarchical principles as the maxim of the sovereignty of the people with the divine right, engage mutually, in the most solemn manner, to use all their efforts to put an end to the system of representative governments, in whatever country it may exist in Europe, and to prevent its being introduced in those countries where it is not yet known.

ARTICLE 2. As it can not be doubted that the liberty of the press is the most powerful means used by the pretended supporters of the rights of nations to the detriment of those of princes, the high contracting parties promise reciprocally to adopt all proper measures to suppress it, not only in their own States but also in the rest of Europe.

ARTICLE 3. Convinced that the principles of religion contribute most powerfully to keep nations in the state of passive obedience which they owe to their princes, the high contracting parties declare it to be their intention to sustain in their respective States those measures which the clergy may adopt, with the aim of ameliorating their own interests, so intimately connected with the preservation of the authority of the princes; and the contracting powers join in offering their thanks to the Pope for what he has already done for them, and solicit his constant cooperation in their views of submitting the nations.

ARTICLE 4. The situation of Spain and Portugal unite unhappily all the circumstances to which this treaty has particular reference. The high

Mr. SHAFROTH:

Mr. President, I should like to have the Senator state whether in that treaty there was not a coalition formed between the powerful countries of Europe to reestablish the sovereignty of Spain in the Republics of South and Central America?

Mr. OWEN:

I was just going to comment upon that, and I am going to take but a few moments to do so because I realize the pressure of other matters. This Holy Alliance, having put a Bourbon prince upon the throne of France by force, then used France to suppress the constitution of Spain immediately afterwards and by this very treaty gave her a subsidy of 20,000,000 francs annually to enable her to wage war upon the people of Spain and prevent their exercise of any measure of the right of self-government. The Holy Alliance immediately did the same thing in Italy, by sending Austrian troops to Italy, where the people there attempted to exercise a like measure of liberal constitutional self-government; and it was not until the printing press, which the Holy Alliance so stoutly opposed, taught the people of Europe the value of liberty that finally one country after another seized a greater and greater right of self-government until now it may be fairly said that nearly all the nations of Europe have a very large measure of self-government.

However, I wished to call the attention of the Senate and the country to this important history in the growth of constitutional popular self-government. The Holy Alliance made its powers felt by the wholesale drastic suppression of the press in Europe, by universal censorship, by killing free speech and all ideas of popular rights, and by the complete suppression of popular government. The Holy Alliance having destroyed popular government in Spain and in Italy, had well-laid plans also to destroy popular government in the American colonies which had revolted from Spain and Portugal in Central and South America under the influence of the successful example of the United States. It was because of this conspiracy against the American Republics by the European monarchies that the great English statesman, Canning, called the attention of our Government to it, and our statesmen, then, including Thomas Jefferson, took an active part to bring about the declaration by President Monroe in his next annual message to the Congress of the United States that the United States would regard it as an act of hostility to the Government of the United States and an unfriendly act if this coalition or if any power of Europe ever undertook to establish upon the American Continent any control of any American Republic or to acquire any territorial rights.

contracting parties, in confiding to France the care of putting an end to them, engaged to assist her in the manner which may the least compromise [sic] them with their own people and the people of France by means of a subsidy on the part of the two empires of 20,000,000 of francs every year from the date of the signature of this treaty to the end of the war.

ARTICLE 5. In order to establish in the Peninsula the order of things which existed before the revolution of Cadiz, and to insure the entire execution of the articles of the present treaty, the high contracting parties give to each other the reciprocal assurance that as long as their views are not fulfilled, rejecting all other ideas of utility or other measure to be taken, they will address themselves with the shortest possible delay to all the authorities existing in their States and to all their agents in foreign countries, with the view to establish connections tending toward the accomplishment of the objects proposed by this treaty.

ARTICLE 6. This treaty shall be renewed with such changes as new circumstances may give occasion for, either at a new congress or at the court of one of the contracting parties, as soon as the war with Spain shall be terminated.

ARTICLE 7. The present treaty shall be ratified and the ratifications exchanged at Paris within the space of six months.

Mr. OWEN:

I ask to have printed in the CONGRESSIONAL RECORD this secret treaty, because I think it ought to be called now to the attention of the people of the United States and of the World. This evidence of the conflict between the rule of the few versus popular government should be emphasized on the minds of the people of the United States, that the conflict now waging throughout the world may be more clearly understood, for after all said the great pending war springs from the weakness and frailty of government by the few, where human error is far more probable than the error of the many where aggressive war is only permitted upon the authorizing vote of those whose lives are jeopardized in the trenches of modern war.

This is the so-called Monroe doctrine. The threat under the secret treaty of Verona to suppress popular government in the American Republics is the basis of the Monroe doctrine. This secret treaty sets forth clearly the conflict between monarchical government and popular government and the government of the few as against the government of the many. It is a part in reality, of developing popular sovereignty when we demand for women equal rights to life, to liberty, to the possession of property, to an equal voice in the making of the laws and the administration of the laws. This demand on the part of the women is made by men, and it ought to be made by men as well as by thinking, progressive women, as it will promote human liberty and human happiness. I sympathize with it, and I hope that all parties will in the national conventions give their approval to this larger measure of liberty to the better half of the human race.

Author's Note: Anyone who believes that the monarchs, after being deposed, forgave and forgot, is not playing with a full deck.

Federal Tax Crime

(should you without your knowledge pay someone else's taxes?)

I believe there is definite possibility that the IRS, The Federal Reserve Bank and the Federal Government are involved in a very sophisticated form of Tax Crime.

For the following reasons:

A person whose business it is to be highly knowledgeable about the inner workings of the tax system has indicated in one of his publications that there are close 100 taxes attached to one loaf of bread.

I have provided to one councillor with his telephone number to derive verification directly from the author. I've done this for the author's security.

Concentration Camps

The secret government plan dubbed Operation Rex 84 came into being at the confidential orders of President Ronald Reagan, and authorized the setting up of at least 23 huge American concentration camps (or "emergency detention centers") to be used in case of a national emergency. Under the Rex 84 contingency, plans were developed for the arrest of "suspect aliens" as well as troublesome homegrown elements considered "potentially subversive," numbering in the tens of thousands. Although the National Security Decision Directives that brought these camps into being have since been canceled, the concentration camps are said to still exist.

Twenty-three camps were originally commissioned via Rex 84, with an additional 20 camps funded through 1990-91 military allocations. In addition to the 43 detainment centers which were commissioned, there are other supplementary facilities which exist nationwide, or which are in the process of being commissioned.

If you are inclined to think that all of this information is made up, I will offer the official view on the subject of American concentration camps. This information is excerpted from the *CRS Report for Congress*, prepared for members of Congress by the Congressional Research Service of the Library of Con-

gress. In the briefing paper titled "Current National Emergency Issues: A Brief Overview" (document 94-596 GOV), under the heading of "Relocation and Detention Centers," it is stated:

"Finally, past Federal Government creation of relocation and detention centers during emergency situations continues to be of public interest. Several weeks after the United States formally entered World War II, President Roosevelt issued E.O. 9066 of February 19, 1942, which effectively ordered the internment of individuals of Japanese ancestry living in the U.S. By early August of that same year, some 110,000 Japanese-Americans — fully 70,000 of whom were legal citizens of the U.S. — had been detained and incarcerated in so-called relocation centers in accordance with the President's order. Congress subsequently sustained the internment order in an act of March 21, 1942, ratifying and confirming E.O. 9066 by making any action in violation of the restrictions laid down by the President, the Secretary of War, or designated military subordinates a misdemeanor punishable by a \$50,000 fine and one year in jail. For the most part, the internees remained in the relocation camps until the surrender of Japan and the end of World War II. Many years later, the injustices perpetrated against the internees were officially investigated and verified, and legislation establishing a procedure and conditions for granting them redress was adopted.

"One of the earliest post-World War II delegations of emergency power occurred with the Emergency Detention Act, which was Title II of the Internal Security Act of 1950. According to section 102 of the detention statute, the President, in the event of an invasion of the U.S. territory or possessions, a declaration of war by Congress, or an insurrection within the United States in aid of a foreign enemy, could declare an 'Internal Security Emergency,' which would make effective special police power provisions of the statute. The Attorney General could 'apprehend and by order detain each person as to whom he, the Attorney General or such officer so designated, finds that there is a

reasonable ground to believe that such person may engage in, or may conspire with others to engage in acts of espionage or sabotage.' The individuals, who were to be detained until the termination of the emergency or appropriate legal action had occurred. Detention centers were maintained at former Army installations in Avon Park, Florida, Tulelake California, and Wickenburg, Arizona. There was also a detention center at the Allenwood, Pennsylvania, ordinance depot.

"In 1968, when riots were devastating various urban centers of the Nation, two references to detention centers heightened public apprehension about them. The first arousal occurred in response to a congressional committee report which said that acts of overt violence by 'guerrillas' in the United States were analogous to a 'state of war' and might justify the use of the detention centers 'for the temporary imprisonment of warring guerrillas.'

"The use of the term 'guerrillas' was regarded by some to be a cryptic reference to black urban rioters. This suspicion was given popular support when a novel by John A. Williams gained wider readership. Actually published in 1967, *The Man Who Cried I Am* discussed, in the context of its own story, a secret governmental scheme called the King Alfred Plan, by which black Americans would be incarcerated in special camps. This fictional situation coincided in the minds of some with the detention suggestion made in the congressional committee report. Undoubtedly, this was not the only stimulus prompting calls for the repeal of the Emergency Detention Act, but it did serve to mobilize opinion in favor of such action. In 1971, Congress enacted legislation overturning the detention center statute."

What the authors of the CRS Report are not in a hurry to tell you is that, regardless of whether the Emergency Detention Act was overturned, the facilities themselves were not dismantled.

Although personal on-site investigation should be done to verify the following information, camps and "detainment facilities" are alleged to exist in at least the following locations: Camp A.P. Hill, Virginia; Fort Chaffee, Arkansas; Fort Drum, New York; and Fort Indian Gap, Pennsylvania; Oakdale, California; Eglin Air Force Base, Florida; Vandenberg Air Force Base, California; Fort McCoy, Wisconsin; Fort Benning, Georgia; Fort Huachuca, Arizona; Wickenburg, Arizona; Elmendorf Air Force Base, Alaska; Eilson Air Force Base, Alaska; Tulelake, California; El Reno, Oklahoma; Tulsa, Oklahoma; Florence, Arizona; Camp McCoy, Wisconsin; Maxwell Air Force Base, Alabama; Mill Point, West Virginia; Allenwood, Pennsylvania; and Camp Krome near Miami, Florida.

Sites of other alleged detention camps include two facilities located at the NASA facility in Mississippi. These camps, we understand, are currently being used for Haitian refugees and for prisoners from the Sheriff's Department in Hancock County. One report suggests that the Marines have been busied at the nearby Pearl River, clearing away logs and other debris for the stated purpose of bringing submarines up the river.

Researching the plans for concentration camps during the 1970s, Dr. William R. Pabst described additional sites:

"Here are the designated sites: tucked away in the Appalachian Mountains of central Pennsylvania is a bustling town of approximately 10,000 people. Fifteen to twenty years ago it was a sleepy village of 400. Allenwood, Pennsylvania is linked to New York City by Interstate U.S. 80. It takes up approximately 400 acres and is surrounded by a 10-foot barbed wire fence. It now holds approximately 300 minimum security prisoners to keep it in shape. It could hold 12,000 people from one day to the next.

"Thirty miles from Oklahoma City on U.S. 66 is El Reno, Oklahoma with an approximate population of 12,000. Due west, 6 miles from town, almost in sight of U.S. 66 is a complex of

buildings which could pass for a small school. However, the facility is overshadowed by a guard house which appears to be something like an airport control tower — except that it's manned by a vigilant, uniformed guard. This is a federal prison camp or detention center. These camps are all located near super-highways or near railroad tracks or both.

"The federal prison camp at Florence, Arizona could hold 3,500 prisoners. It is presently kept in condition by approximately 400 legally convicted prisoners.

"Some of the other locations are: Tulelake in California — now in private hands. Some of the others: 'We have Mill Point, West Virginia. At Montgomery, Alabama we have a federal civilian prison camp at Maxwell Air force Base... There's one at Tucson, Arizona, David Munson Air Base...'

"And that brings us to a facility in Florida called Avon Park. I sent a representative to see what was at Avon Park, Florida. He found the Avon Park bombing and gunnery range, which is also listed as the 56th Combat Support Squadron of the U.S. Air Force; which is also listed as the Avon Park Correctional Institute. No one is permitted entrance and probably there is no overfly."

Pabst further reported that, "The cadre of specialized persons to enforce this [concentration camp] plan are found in the U.S. Army Reserves - Military Police Prisoner of War Command at Livonia, Michigan. Mr. Fennerin of the 300 Military Police POW Command at Livonia told me, when I called him from the Federal Information Center at Houston, that the camps in the command were for foreign prisoners-of-war and for 'enemies of the United States.' I asked him if enemies of the United States included U.S. citizens. He became angry, wouldn't deny it, and referred me to a very sinister individual at the Army Reserve facility here at Houston who I talked to who explained to me that the prisoners were called "inventory" and "internees." He would not deny that the camps were for U.S. citizens.

"I called the Pentagon, spoke with the defendant there, and then with the provost marshal for the Fifth Army, and do you know what? Not one of these persons would deny that the system was for U.S. citizens. The provost marshal for the Fifth Army — when I mentioned the names of all the camp sites — said, 'Well at least you've got that right.'

"The names of the detention facilities that I gave him were a list that I had acquired from the *Ozark Sunbeam* [newspaper]. That list of names was the same list of facilities designated under the old Detention Act of 1950 as 'emergency detention centers.' But there is only one problem: That act was supposed to have been repealed in 1971. After some research, I found out what the problem was. One congressman — when the hearings were held for the repeal of the Emergency Detention Act — mentioned that there are 17 other bits of law that provided for the same thing. So it didn't matter whether they ever repealed the Emergency Detention Act. The public was in fact tricked by the Congress of the United States!"

An additional list of detention camps has been formulated by researcher Jeff Thompson in his study of FEMA (Federal Emergency Management Agency) maps. He states that each of these sites can hold between 32,000 and 44,000 people, and that they share other similarities. Thompson informs us that: "They all have a large body of fresh water. They all have a train system within 5 miles or closer. They all have a major highway relatively close. They all have a major airport relatively close. But for all of these transportation systems all in one area, these locations are inordinately uninhabited (with the exception of a couple)."

"These locations are:

1. Cokeville to Kremmerer, Wyoming, in west of state/Ab-saroka Ridge with Fontanelle Creek and Reservoir/Interstate 80 and train/airports at Rock Springs, Wyoming and Salt Lake City, Utah on I-80.

2. Sheridan/Bufalo, Wyoming/Lake De Sniel/Interstate 25 with train to Sheridan; airport at Sheridan/Oil fields.
3. Wheatland, Wyoming, north of Cheyenne/Wheatland Reservoir and Sybille, Laramie and North Laramie Rivers/Interstate 25 and train; airports at Cheyenne and Laramie down I-25.
4. Yankton/Vermillion, Nebraska, north of Sioux City/Missouri River/Interstate 29 nearby, U.S. 20 and 81; train to Sioux City; airports at Yankton, Sioux City, and Norfolk, Nebraska.
5. Chadron, Nebraska in northwest Nebraska/Niobrara and White Rivers/U.S. 20 and U.S. 385; train to the southwest; airport at Chadron and Alliance, Nebraska.
6. McCook, Nebraska in southwest/Republican River and Swanson Lake/U.S. 83 and U.S. 34; train; airport in McCook, Nebraska.
7. Amarillo, Texas/Lake Meredith/Interstate 40, U.S. 87/I-27; lots of trains; large airport. This may be a very significant place because there are UN and MJTF [Multi-Jurisdictional Task Force] troops there already.
8. Rothschild, Wisconsin, Big Eau Pleine Reservoir/U.S. 51 and U.S. 10; train to nearby Stevens Point; airport at Mosinee north on U.S. 51.
9. Near Paoli, Indiana in south central portion of state/Patoka Lake, East Fork White River/Hoosier National Forest/Interstate 64 and 65, and U.S. 150; trains to north and to east down U.S. 150; airports in Evansville, Louisville, and Bloomington.
10. Terre Haute, Indiana, to the south of Terre Haute/Wabash River/I-70 and U.S. 41; trains to north, south, east, west; airport in Terre Haute.
11. Fort Wayne, Indiana - Huntington, Indiana/Maumee River/Huntington Lake/I-69 and U.S. 30; trains everywhere; airport in Fort Wayne.

12. Kalamazoo, Michigan - Niles, Michigan or Benton Harbor/St. Joseph River, Dowagiac River, Lake Michigan about 25 miles/I-94, I-80, U.S. 131, U.S. 12; a lot of train connections; airport in Benton Harbor and near Kalamazoo.
13. Midland, Michigan, south of Saginaw Bay, close to Freeland/Pine and Saginaw Rivers/I-75; train to the airport or nearby.
14. Dundee, Michigan, south of Detroit/Raisin and Huron Rivers/I-75 and U.S. 23; train; airport near Southgate.
15. Defrance, Ohio/Maumee River/U.S. 24; lots of trains; airport at Maumee, Ohio.
16. Ashtabula, Ohio, in northeast corner of state/Lake Erie and Grand River/I-90; lots of trains; airports in Euclid, Cortland, Warren, and Erie, Pennsylvania.
17. Coshocton, Ohio or Newcomerstown/Walhonding River/I-77 and I-70, U.S. 36; train, but no close airport.
18. Portsmouth, Ohio/Scioto River and Ohio River/U.S. 52 and U.S. 23; train, but no airport. Rickenbacker AFB is far to the north.
19. Batavia, New York/I-90, rivers and trains galore; airports at Depew and Greece.
20. Hudson, New York/Hudson river/I-87; trains; airport at Poughkeepsie.
21. Gouverneur, New York/Oswegatchie River/trains; airports in Watertown and Ogdensburg.
22. Brounwood, Texas/Lake Brounwood and Bayou River/U.S. 183 and U.S. 67; train (one goes through Fort Hood); airport.
23. Fairbanks, Alaska/Nenang River/Star Route 3 from Anchorage; trains; airport;Fort Wainwright: Army."

Another source of information about concentration camps is Canadian journalist Serge Monast, the author of a book called *The United Nation's Concentration Camp Program in America* (which was unavailable to me at the time of this writing). I was

able, however, to obtain a copy of a press release from the *International Free Press Network* which included an excerpt from an upcoming book from Monast. Although some of the details of Monast's account sound unlikely, I am including this information on the basis of providing the most complete reporting of the subject possible. The reader is cautioned about the need for confirmation of this information. Monast writes:

"We do know that the military-industrial complex and various federal government agencies have constructed and are working in many installations, underground bases and detention facilities; some of them accommodating large numbers of people at very deep underground [levels], and quite sophisticated. According to the latest reports such deeper facilities may be several hundred feet underground. Tunnels could be as large as 50 ft. by 50 ft. in diameter and chambers as much as 100 ft. high. In some installations truck or railway traffic might be important. Two-track railroad or two-lane highway tunnels [are] as much as 31 ft. wide by 22 ft. high. Camouflage has been considered. Under the direction of FEMA much work, including a great deal by the Corps of Engineers, has been done to design and construct underground or earth-covered key facilities, and also underwater special facilities along the Atlantic and Pacific coasts of the U.S., as well as in the Great Lakes region. We also learned from covert sources that there are similar deep underground facilities in Canada, Sweden, Switzerland, France, Saudi Arabia, Israel and Russia. FEMA and the Pentagon administer at least 50 secret underground command posts around the U.S. We have been informed that the NORAD base is also the 'National Warning Center' for FEMA. This is the place from which warnings for Canada and [the] U.S. are to... round up people under United Nations Authority. The command center is jointly staffed by both Canadian and U.S. military personnel. the NSA (National Security Agency) operates with computers which are engaged in a massive surveillance of much of the world telephone, telex,

fax, radio, TV and microwave communications, including surveillance of domestic, internal U.S. communications by ordinary citizens. Ninety-six secret FEMA underground bases and facilities are located in Pennsylvania, Maryland, West Virginia and North Carolina. And we are not talking about LASL's unusual underground lab (Los Alamos National Laboratories [in New Mexico]) for instance. We also know that they extended underground bases and facilities as deep as 6,000 ft., but [it] looks like they even reached 8,000 ft. deep. We have maps, official documents, designs and exact locations of deep underground bases and detention facilities; pictures of equipment used for tunneling technology; information concerning underground structures; designs and construction; the flame-jet tunneling system; the high-temperature protective suit designs, and more...

"Some, and we say only some of the approximate locations of those underground bases and detention facilities are situated in: Kennesaw Mountain, just outside of Marietta, Georgia, and Green Mountains on the outskirts of Huntsville, Alabama. Other 600 ft. diameter cavities up to 4,000 ft. below the ground are located in Kingman, Arizona; Mohave County, Inyo County, California; Argus Mountains near Darwin (Argus Park); Mesa and Montrose Counties, Colorado (Sinbad and Paradise Valleys); 40 miles southeast of Moab, Utah; Pershing County, Nevada, in the Shawave and Nightingale Mountain ranges; Mesa County, Colorado in Unaweep Canyon 30 miles southwest of Grand Junction; Emery County, Utah, 10 miles south of Gree River; Winkler and northern Ward Counties, Texas, near... Kermit and Wink; Mohave County, Arizona, northwest of Kingman; Franklin County, Alabama, near Gravel Hill; Kansas and Nebraska, granitic basement areas; Oglethorpe and parts of Greene, Wilker and Elbert Counties, Georgia, near Highway 77 and the Georgia railroad; Chira Lake Naval Weapons Center, under Argus Park, California; Prince William Sound and the Kenai Peninsula, Alaska; southwestern Minnesota; Santa Bar-

bara, California; Keweenaw Peninsula, Michigan; area of Cornwall, Pennsylvania; Vermillion Cliffs, Coconino County, Arizona; Grand Washington Cliffs; area of Barbeton, Ohio; area of Rifle, Colorado; Morgantown, West Virginia; area of McConnelville, Ohio; Logan County, Illinois; Kunia, Hawaii; near the small town of Blue Ridge Summit, Pennsylvania, 'Raven Rock' or 'Site R'; Warrenton, North Virginia; Bear Wallow Road on Viewtree Mountain, and one on Rt. 802, Virginia; in the foothills of the Manzano Road Mountains, near Albuquerque, New Mexico; Atchison, Kansas; Amherst, Massachusetts; Napa, California; near Oakville, Sugar Grove, West Virginia; Ft. Belvoir, Virginia; West Point, New York; Groom Lake or Area S-4 near Nellis Air Force Base, Nevada; in the national forests in the Rocky Mountains of southwest Montana; Fort Meade, Maryland; Mount Pony, east of Culpepper, Virginia; on Riggs Road, off of Rt. 108, between Beetle Creek [Battle Creek?], Michigan; Denton, Texas; Bothell, Washington; Round Hill, Virginia; Emmitsbury, Maryland; Charlottesville, Virginia; Cheyenne Mountain, Colorado; Boston, Massachusetts; Olney, Maryland; Atlanta, Georgia; Chicago, Illinois; Kansas City, Missouri; Presidio, California; Fort Custer, Michigan; Richmond, Kentucky; Forest Park, Georgia; Palo Alto, Texas..."

We have also received reports that many small holding areas are being constructed at various locations around the nation. These are nothing more elaborate than fenced-in open fields of between 100 and 200 acres in uninhabited areas. Airline pilots have reported the appearance of these alleged detainment locations at numerous sites in the United States, including in western mountainous areas. These areas sometimes lack any identification whatsoever, while at other times they have signs saying such things as "Keep Out, Zoo Annex." On-site observers have reported that the fences in these facilities are sometimes partially buried, presumably to make escape from the areas more difficult.

One site near Topeka, Kansas covers 80 acres and bears a sign stating "Zoo Annex." Local citizens investigating the area have found that it is controlled by the Department of Corrections.

Another camp has been stated to exist near Marseilles, Illinois. There is a 300' by 300' area enclosed by fences and barbed wire, and an observation tower is located at each of the four corners of the facility. There is a reservoir connected to the camp, and fences inside break the facility into smaller yards. Observers suggest that it is large enough to hold 1400 detainees.

A letter to the editor in the July 1994 *Patriot Report* discusses the location of a detainment facility in Winnemucca, Nevada, which I have had verified by other sources:

"Gentlemen: Are you aware of the apparent detainment or concentration camp put up by the government 2 years ago on 1-80, mile marker 112, near Winnemucca, Nevada? This is on the south side of the road about 3/4 of a mile off the highway. I have not personally seen it, but several of my friends have. They say it appears to be able to hold around 5,000 people and is empty at this time. There are possibly three others sites in Nevada that have troops in them — one near Wells, 50-60 miles from Wendover toward Wells, one about 10 miles from Elko, one between Winnemucca and Wells, way out next to mountains — you can hardly see it."

From the *Intel Report* of the Militia of Montana, June 22, 1994 is a report dated June 15, 1994:

"Concerning unusual activity in Warren County, Pennsylvania and the northwestern portion of the Allegheny National Forest.

"A. Confirmed: large air strip (at least 500 yards wide), hangar and inaccessible (by road) area of western edge of Allegheny National Forest.

"B. Hiking trails, snowmobile trails, access roads, etc. in most of Allegheny National Forest were closed to the public this spring.

"C. Large portions of Allegheny National Forest fenced in with high chain link fence.

"D. Area within the Allegheny National Forest has been replanted. Sign states 'International Releafing Project.'

E. Treetop high towers have been erected in straight line from air strip from northeasterly direction. Towers extremely well lit up, very visible when lights are on.

"F. Reported, but unconfirmed that cameras and voice activated devices set up along some trails and roads in the Allegheny National Forest. (Note: The United States Forest Service has admitted to placing cameras in the forests in the northwestern part of the United States. Confirmed).

"G. An area of the National Forest is fenced in 'to control animal movement' by high chain link fence with barbed wire on top. Towers are in place outside the fenced area.

"H. Security was increased at large, local refinery (that is no longer owned by local people). The refinery supplies fuel to ships on St. Lawrence Seaway and Lake Erie, fuel to airports as far away as Rochester, New York, and gas to a large portion of the mid-Atlantic states and Ohio.

"I. This sleepy, little community (Warren, Pennsylvania) was infested with foreigners for about two weeks, earlier this year (Winter). Foreigners are very unusual in this community.

"J. Emergency Evacuation Program, in conjunction with FEMA, now in effect for entire county.

"K. Numerous sightings of black helicopters and military aircraft have been sighted in remote areas.

"L. Security at the local shopping mall has been increased. Mall now closes earlier and the doors are chained and padlocked, as well as being locked. (Note: It appears they are gearing up for civil unrest in this county and also the areas in the Al-

legheny National Forest that have been fenced in with towers could very well be a new holding facility for government dissenters)."

There are confirmed reports that massive new detention centers are being built in Ohio and Alabama for control by FEMA (Federal Emergency Management Agency), and that a huge FEMA prisoner transfer terminal is being constructed in Oklahoma City, Oklahoma. Mark Koernke reports that there is a detention camp readied at Indianapolis, Indiana, and that an aerial survey has been done of the multiple thousand-acre facility, including photos. The area is surrounded by a fence with barbed wire pointing inward, and includes a helicopter pad, large sewer treatment facilities, and rows of barracks. Signs on the center indicate only Blue Zone, Red Zone, and Green Zone.

I would be the first to admit that the locales of the concentration camps and holding facilities which I have listed above deserve further study. It is possible that there may be mistakes in identifying some of these locations, and some of these facilities may have been constructed for completely innocuous purposes of which we are unaware. Some of them may even actually be "Zoo Annexes," for all I know. In this chapter I have included a complete list of all of the credible reports of detention facilities which I have obtained, but further research — verifying or discrediting each of these sites as locations for concentration camps — should certainly be done by interested researchers.

Whether or not all of these facilities are intended to be used as detainment camps for U.S. citizens, it is obvious that they could be used for such a purpose, and that the government is not ruling out such a possibility. Proof of such a wild allegation? Try the Army field manual FM-10, "Civil Affairs Operation."

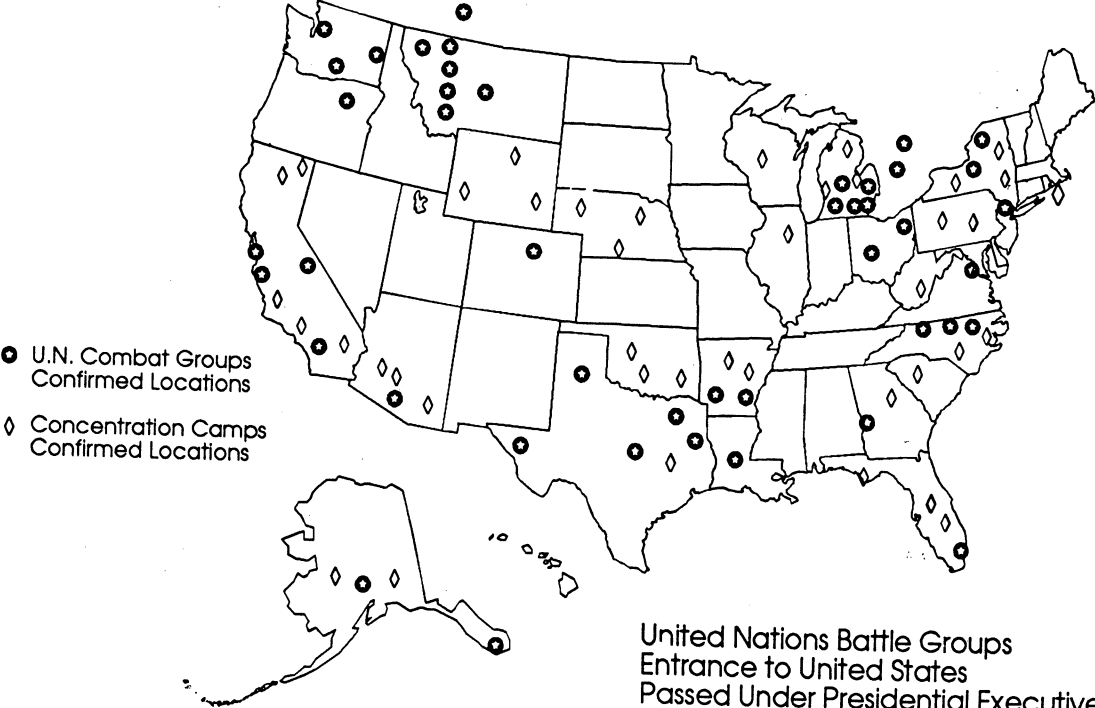
This Army manual states that one of the purposes of Army Civil Affairs is "Item 4. Assumption of full or partial executive, legislative and judicial authority over a country or area." This is

said to include: "small towns and rural areas, municipalities of various population sizes, districts, counties, provinces or states, regions of national government."

In the study outline of the manual, on page j-24, listed under the heading "Penal Institutions 1-B," there are a number of entries under the designations of "concentration camps" and "labor camps," while on page d-4 is a receipt for seized property. This sample receipt is in English.

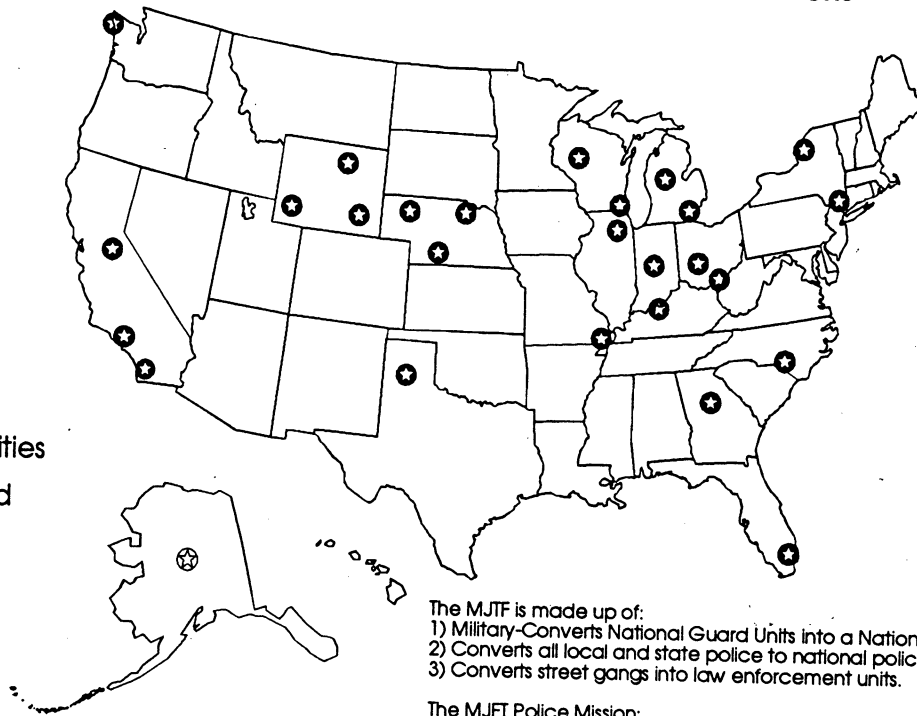

Since 1933 Congress has passed or recodified over 470 significant statutes delegating to the President powers that had been the prerogative and responsibility of the Congress since the beginning of the Republic... few if any foresaw that the temporary states of emergency declared in 1933, 1950, 1970, and 1971 would become what are now regarded collectively as virtually permanent states of emergency. Forty years can, in no way, be defined as a temporary emergency. In the view of the Special Committee, an emergency does not now exist. Congress, therefore, should act in the near future to terminate officially the states of national emergency now in effect."(*Congressional Record* — Senate, vol. 119 part 29, 93rd Congress, 1st session, November 19, 1973).

Here are examples of some of the Executive Orders which are currently in place, and which the President can employ any time an event takes place which can be characterized as a national emergency (and the definition of what constitutes an emergency is purposefully and absolutely vague):

-EO 10995, authorizing the suspension of the freedom of speech and the commandeering of all communication media.

-EO 10997, authorizing the takeover of electrical systems and other fuel sources.

-EO 10998, providing for the government control of food sources, including farms.

-EO 10999, which authorizes the control or confiscation of the nation's transportation sources, public and private.

-EO 11000, which gives the government the right to form work brigades of citizens.

-EO 11001, providing for the takeover of all health, education, and welfare functions and facilities.

-EO 11002, authorizing a national registering of the populace.

-EO 11003, authorizing the takeover of all airplanes and airports.

-EO 11004, which gives government the mandate to relocate populations from one area to another.

-EO 11005, which provides for the government to take over railways, waterways, and public storage facilities.

THE FEDERAL RESERVE IS NOT A GOVERNMENT AGENCY. The Federal Reserve is privately owned by a group of primarily foreign, bankers. In 1913, Congress sank America into eternal debt by giving the power to issue currency and control the American economic system to the Federal Reserve Bank. Who are the owners or chief shareholders of the Federal Reserve? Originally, there were reportedly 203,053 shares of Federal Reserve stock, of which approximately 65% were owned by foreigners and approximately 35% (72,000 shares) were owned as follows:

1. Rockefeller's National City Bank = 30,000 shares.
2. Chase National = 6,000 shares
(currently Chase Manhattan and owned by David Rockefeller)
3. The National Bank of Commerce (now known as Morgan Guaranty Trust)
= 21,000 shares
4. Morgan's First National Bank = 15,000 shares.

Interestingly, the total shares owned by Rockefeller's interests equal 36,000 shares and the total of Morgan's interests equal 36,000 shares.

Although The Federal Reserve Act of 1913 provided that the names of the owner banks be kept a secret, R.E. McMaster, publisher of the newsletter, The Reaper, discovered, through confidential Swiss banking connections, that the following banks have controlling stock interest in the Federal Reserve:

4. Warburg Bank of Hamburg, Germany and Amsterdam

8. Chase Manhattan Bank of New York (Controlled by the Rockefellers)

In his impeccably researched book Secrets of the Federal Reserve, Eustace Mullins states: "Because the Federal Reserve Bank of New York sets interest rates and controls the daily supply and price of currency throughout America, the owners of that bank are the real directors of the entire system. These shareholders have controlled our political and economic destinies since 1913." Those shareholders making up Mullins list are almost identical to the one compiled by the Swiss banking source.

virtually everything about guns — worldwide. The working paper proposes that, "Arms permitted (legally sold and licensed) for civilian use, whether imported or of domestic manufacture, should also be subject to controls at all points, from production and acquisition up to the time they are sold to an individual (citizen)."

If it is not obvious, what the New World Order is offering is world peace at the price of a total world dictatorship. Some see this as a reasonable exchange.

Possibly the most decisive — and scary — of President Clinton's recent actions ushering in the New World Order and U.N. world control was the signing of Presidential Decision Directive 25 (PDD-25) on May 3rd, 1994, an action which places U.S. military commanders under the jurisdiction of the United Nations during U.N.-controlled actions. Not surprisingly, the main text of the directive remains classified. In response to requests for a copy of the document, Anthony Lake, assistant to the President National Security Affairs, grudgingly released a 15-page "unclassified summary."

PDD-25 was originally written as Presidential Review Directive 13 (PDD-13), issued in 1993, which included a disclaimer penned by General Colin Powell, at the time the chairman of the Joints Chiefs of Staff. This disclaimer "allowed U.S. commanders under U.N. command to not comply with orders which they believe are: (1) outside the mandate of the mission, (2) illegal under U.S. law, or, (3) militarily imprudent or unsound." PDD-25 has had these exemptions removed. It is also important to note that this presidential directive does not specify where these U.N. expeditionary actions are proposed to take place, whether in foreign countries or inside the borders of the United States. The globalists see no difference.

Two weeks after the release of PDD-13, the *New York Times* offered the comment that the directive was a turnabout from "long-standing tradition" which did not allow American soldiers

to be commanded by foreign commanders. The Clinton Administration is considering United Nations peacekeeping operations in which Americans serve under foreign command on a "voluntary basis."

What is the ultimate significance of this stroke of a pen internationalist door wide for intervention within the United States? Hardly a voice is raised in protest and books that the press characterizes as "wing extremist." G. Gordon Liddy's "The Lies... leaps to mind.

Another recent document is a working paper composed by the Clinton Administration on June 24, 1994, titled "National Security Strategy for the Russian Federation." THE CONSTITUTION OF THE UNITED STATES OF AMERICA

Ratified in 1788

PREAMBLE

We the People of the United States, in order to form a more perfect union, establish justice, insure domestic tranquillity, provide for the common defense, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity, do ordain and establish this Constitution for the United States of America.

Article 1

LEGISLATIVE DEPARTMENT

Section 9. Powers Denied to the Federal Government

g. No money shall be drawn from the Treasury, but in consequence of appropriations made by law; and a regular statement and account of the receipts and expenditures of all public money shall be published from time to time.

Article 2

EXECUTIVE DEPARTMENT

Section 2. Powers of the President

a. Military powers; reprieves and pardons. The President shall be commander in chief of the army and navy of the United States, and of the militia of the several States, when called into the actual service of the United States; he may require the opinion, in writing, of the principal officer in each of the executive departments, upon any subject relating to the duties of their respective offices, and he shall have power to grant reprieves and pardons for offences against the United States, except in cases of impeachment.

b. Treaties; appointments. He shall have power, by and with the advice and consent of the Senate, to make treaties, provided two-thirds of the Senators present concur; and he shall nominate, and by and with the advice and consent of the Senate, shall appoint ambassadors, other public ministers and consuls, judges of the Supreme Court, and all other officers of the United States, whose appointments are not herein otherwise provided for, and which shall be established by law: but the Congress may by law vest the appointment of such inferior officers as they think proper, in the President alone, in the courts of law, or in the heads of departments.

Article 6

GENERAL PROVISIONS

b. Supremacy of the Constitution. This Constitution, and the laws of the United States which shall be made in pursuance thereof; and all treaties made, or which shall be made, under the authority of the United States, shall be the supreme law of the land; and the judges in every State shall be bound thereby, anything in the Constitution or laws of any State to the contrary notwithstanding.

c. Oath of office no religious test. The Senators and Representatives before mentioned, and the members of the several State legislatures, and all executive and judicial officers, both of the United States and of the several States, shall be bound by oath or affirmation to support this Constitution.

Article 1

LEGISLATIVE DEPARTMENT

Section 10. Powers Denied to the States

a. No State shall enter into any treaty, alliance, or confederation; grant letters of marque and reprisal; coin money; emit bills of credit; make any thing but gold and silver coin a tender in payment of debts; pass any bill of attainder, ex post facto law, or law impairing the obligation of contracts, or grant any title of nobility.

b. No State shall, without the consent of the Congress, lay any imposts or duties on imports or exports, except what may be absolutely necessary for executing its inspection laws; and the net produce of all duties and imposts, laid by any State on imports or exports, shall be for the use of the treasury of the United States; and all such laws shall be subject to the revision and control of the Congress.

c. No State shall, without the consent of Congress, lay any duty of tonnage, keep troops, or ships of war in time of peace, enter into any agreement or compact with another State, or with a foreign power, or engage in war unless actually invaded, or in such imminent danger as will not admit of delay.

Since the Federal Gov't is engaging in acts of treason and war crimes against the people the States now have a right to defend themselves.

It is true that we live in a city and this is, a local city gov't
But it is more true, that we live in a country because if our
country didn't exist our city wouldn't exist. Therefore it's
important that we know when dangerous things are going on in our
country.

This matter I have brought up in my letter regarding media images

That's what I do. And I'm good at it. I can see the tiny specks of
where things are going and make the right moves to cut through
chaos so destruction doesn't occur.

What I have to describe is complex and it's taken me much time
and work to figure out how to explain it to you, to melt away

some kind of malicious intention behind it.

I don't believe the majority of the people of America live lives
immersed in violence nor do I believe the majority of Americans
want to view violence as entertainment. Because most Americans
are constructive positive people.

Think of all the people you know and you'll agree.

Then where is the money coming from to push the images of
violence and degradation onto us day and night and night and day.

The reason, you don't ask that question is because these images
are coming through channels which you have long considered normal
sources of information.

You go out to buy a newspaper and there it is. Well that's the
way it must be. Not true. That isn't the greater reality.

You're not conscious of the unusual consistency of the same violent message. In a country of 250,000,000 people the majority of which are not violent why is there so much emphasis on violence.

The reason is that someone is trying to create, a climate of violence to either wither the people down into a state of fear or to instigate the less stable into violence.

This violence propaganda is actually an act of war against our country.

Let me read you just a tiny part of the enemy's plan for world conquest which was published in the 1800's.

"It is from us that the all-engulfing terror proceeds. We have in our service persons of all opinions, of all doctrines, monarchists, demagogues, socialists, communists, utopian dreamers, extremists.

We have harnessed them to the task: each one of them on his own account is boring away at the last remnants of authority, striving to overthrow all established forms of order.

By these acts all States are in torture; they plead for tranquillity, they are ready to sacrifice everything for peace;

but we will not give them peace until they openly acknowledge our international super-government. There was no super gov't in the 1800's. Neither the League of Nations nor the UN existed in the 1800 hundreds.

But today there is an international governing body. And the people who wrote those words have been working since that time creating conflict, so that a world governing body would be needed.

The charter of the UN states that all rights are derived, from the UN.

The US Constitution and the Declaration of Independence state that the unalienable rights to life, liberty, and property are God-given rights that no man or government can abridge.

My friends there is and has been a war being waged against the people of America, it is an incremental, covert war whose two main silent lead points are political and governmental treason.

Did you know our President has signed an agreement, the details of which are kept secret from us, giving UN commanders authority over US commanders in UN situations. A UN military base is a UN situation. The President has allowed the establishment of many UN military bases on US soil? Presidential; Decision Directive 25(PDD-25) While at the same time dismantling our own military bases. In essence giving control of US soil to foreign soldiers, foreign commanders and foreign executives who have no allegiance to Our Constitution, Who believe their authority is equal to GOD, This is what happens in war, armies take over the territory of other nations. Our land has been taken over by foreign forces without a fight through political treason. Our federal leaders have surrendered US soil to foreign military powers. Still you will say what threat is there ? You are going to see what the threat is shortly.

The President is Commander and Chief of the Armed Forces. To surrender control of the armed forces over to foreigners is equivalent to surrendering the Presidency. For the Constitution does not allow the President to transfer his command over our military forces to anyone. Especially so, to foreign forces on our own soil. Our national and international interests are not the same as the UN. The UN does not believe in the morality of equality under GOD. In the UN there are executives who are of the persuasion of Monarchist Superiority. In the secret treaty of Verona during the same time the plans for world conquest surfaced, the Monarchies of Europe swore to wage war on and overthrow all nations elected by the majority,

The fact that a set of Plans for world conquest was found in 1884 stating that a war of terror would be waged on nations forcing them to beg for peace to a world governing body, which at that time didn't exist, but which exists today and the level of constant worldwide violence indicates that those who wrote the words I read have been at work since that time engaged in carrying out their plans.

Unless

Somebody was planning to do something that would require soldiers who wouldn't hesitate in attacking American citizens. Foreign soldiers wouldn't hesitate in attacking US citizens. Unless somebody was planning to create violence in our country.

And you know? There seems to be an indication that somebody is planning to do something like that.

Did you know that concentration camps have been built all over this country? Concentration camps above and below ground. Enough concentration camps to hold hundreds of thousands of people.

How did I find this out from this book. And what of the author, has he written a book and left town? No at the end of the he gives his mailing address and invites people to write. He's ready to face up to what he's written. I know because I wrote him a letter and he answered it. The treaty of Verona, the lists of concentration camps and much more will be given to the public record and each councillor.

What all these concentration camps mean is that somebody believes there is going to be a tremendous level of violence which will require incarceration facilities for hundreds of thousands of people.

Who are the people who will be incarcerated ? Canadians ? Mexicans
? Belgians ? Chinese ?

No I don't think so. I think they're meant for the people who are
near them. I think they're meant for hundreds of thousands of
Americans.

Not only that, but when you incarcerate hundreds of thousands of
people, a good many of those people are going to resist. What does
that mean ? It means that thousands of people will be killed.

Now let's look at this a little bit closely.

If there is a war, the leaders tell the people there is a war. The
leaders tell the people who the enemy is. The leaders supply the
people with weapons and go into battle to stop the enemy from
achieving its intention.

Why haven't the American people been told about what this tremendous
threat of impending violence is ? Which will be so intense that it
require all these concentration camps ?

Why hasn't our president and our congress told us about this great
danger.

Surely we would want to know what this threat is so we could
participate in preventing it.

Since they haven't told us about what this threat of violence is,

It must mean that they don't want to stop it.

That they want it to happen.

And when you want something to happen what do you do.

You do everything you can to make it happen.

In Viet Nam they had an expression when they were facing the enemy
and it was kill or be killed.

And that expression was And there it is.

The Congress and the President of the United States have conspired
with foreign powers and are preparing to wage against the American
people.

Neither has the Boston Herald told us, a newspaper that loves
violence, nor have we been warned by the Washington Post, The New
York Times, The Boston Globe, the Los Angeles Times and so forth and

United States Constitution

Article 1 Legislative Department

Section 9. Powers Denied the Federal Government

Sub Section g. No money shall be drawn from the Treasury, but in consequence of appropriations made by law; and a regular statement and account of the receipts and expenditures of all public money shall be published from time to time.

In 1913 the Congress gave control of the management of the public money to the Federal Reserve Bank. The Federal Reserve Bank is a privately owned bank primarily owned by foreigners, people who are not US citizens and executive who are not sworn to defend and uphold the Constitution. The Federal Reserve Bank gives no regular detailed accounting of what it occurs with the public funds.






