To The Honorable, The City Council:

I am hereby requesting the appropriation of a grant for \$5,000 from the U.S. Department of Housing and Urban Development to the Grant Fund Other Ordinary Maintenance Account (\$2,500) and Travel & Training Account (\$2,500) to provide funds for the development of First Time Home Buyer classes in English, Spanish, Portuguese and Haitian Creole.
