ORDERED:

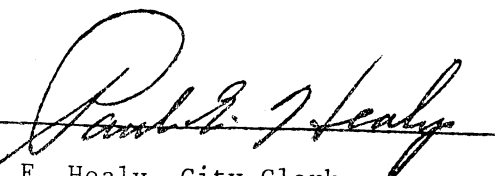

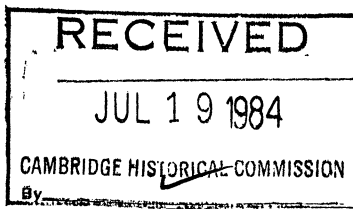
