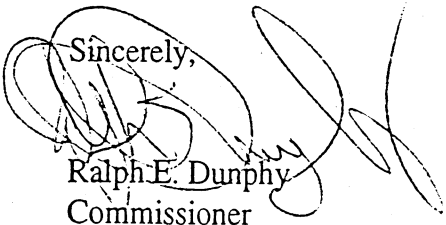

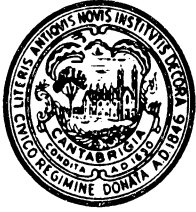
Dan Evans has suggested you contact the License Commission and Health Department to obtain approval to place tables on your own property.

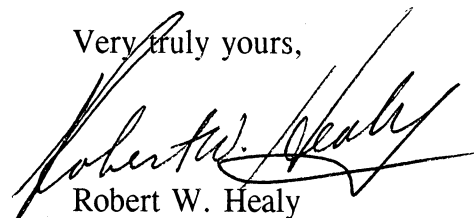
To The Honorable, The City Council:
