To the Honorable, the City Council:

I respectfully request your favorable consideration for an additional appropriation in the sum of \$35,000 to the Executive Department, Schedule F-26 - Architectural Fees - High Schools; said sum to be included in and made part of the 1973 Tax Levy, in order that we might continue our efforts as it relates to our High School Complex.

I plan to engage through the office of Eduardo Catalano an educational consultant acceptable to myself and the Superintendent of Schools who will work with the community and the professional staff of the School Department, as well as with Eduardo Catalano, for the next several months.

We all recognize that this is a very modest appropriation request in this entire planning process but I make this request in order that the planning process continue to move forward in this significant educational community interest.

This appropriation will produce the following results:

1. Provide the best educational program to meet the needs of Cambridge
2. Provide the most economical solution
3. Prepare a program that is eligible for State aid, reimbursable at 65% of the project cost.

The investigation will include studies relating the educational needs to the reuse of existing facilities to site conditions, all leading to a most economical proposal.
