The Committee on Roads & Bridges would submit the following report on the petition of A. K. P. Welch for certain improvements at the corner of Brattle and Craigie Streets.

We would recommend that that portion of the petition asking that the grade of the street and the width of the sidewalk opposite his residence may be established, be granted.

As regards that portion of the petition asking that a portion of his land may be taken to improve the streets aforesaid your committee find that a very acute and unsightly angle exists at the place mentioned in the petition and that Mr. Welch, in consideration of the laying at the expense of the City of Seventy four feet and five inches of Circular edgestone at the junction of said streets, is willing to deed to the City Six Hundred & Sixty Four Square Feet of his land for the sole purpose of widening

and improving the highway at that point according to the plan herewith submitted. We therefore recommend that the City ^{accept} such deed to that effect as shall be approved by the City Solicitor and that said edgestone be laid in accordance with the accompanying order.

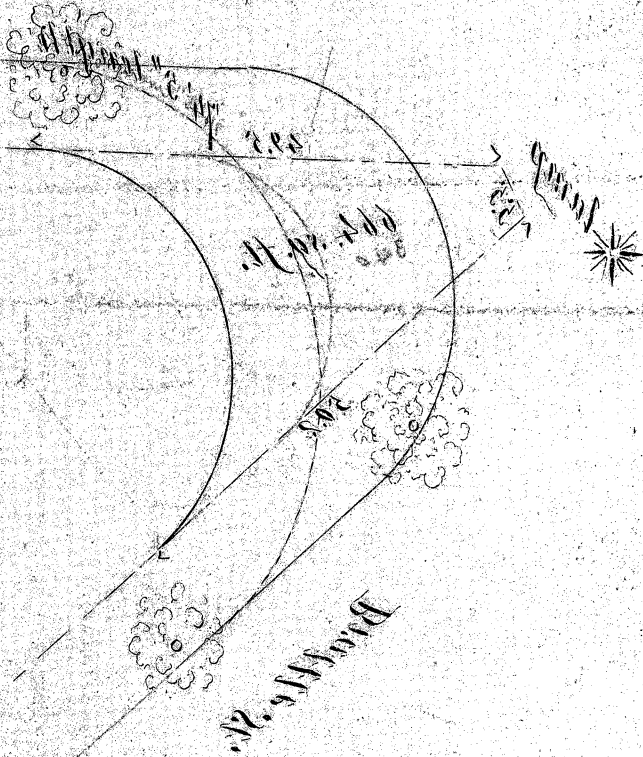
Crangie St.
